## (1) GENERAL

In terms of the Railways Board's instructions communicated vide letter No. E(P&A)I-2001/RT-2 (KW) dated 02.01.2004 and letter No. E(P&A)I/2010/RT-2 dated 11.09.2010,28.06.2011,15.07.2011 circulated under S.C.No.12/04, 131/10, 99/11 & 107/11 applications are invited in the format enclosed as Annexure-'I' from willing and eligible Drivers/Loco Pilots belonging to safety categories seeking retirement and employment to a suitable ward under this scheme during the first half of 2012 i.e. January-June,2012.

## (2) <u>ELIGILIBLITY CONDITION</u>

Category	Eligibility Criteria as on 01.01.2012.	
DRIVERS/LOCO PILOTS	(i)Should be in the age group of 55 to 57 years	
	(ii)Should have completed 33 Yrs of Qualifying Service.	

(Note: For determining eligibility for seeking retirement under this scheme, Grade Pay corresponding to the post against which the employee is working on regular basis will be taken in to account.)

## NOTE:

- 2.1 The conditions of eligibility, in the case of wards, being considered for appointment would be the same as prescribed for direct recruitment from the open market
- 2.2 All conditions for appointment, such as age-limits, educational qualifications, etc, for the wards of such employees who seek retirement under this scheme shall be determined with reference to the above cut-off date i.e 1<sup>st</sup>.January, 2012.
- 2.3 The last date for submission of requests for retirement and consideration of a ward for appointment under the Scheme is fixed as 25.02.2012.
- 2.4 Employees who desire to withdraw their requests for retirement may be allowed to do so not later than 20.03.2012. No request for withdrawal of request shall be entertained thereafter.
- 2.5 The employment under the scheme would be guaranteed only to those found eligible/suitable and finally selected as per procedure. The retirement of the employee and appointment of the ward will take place simultaneously.
- 2.6 Liberalized Active Retirement Scheme for Guaranteed Employment for Safety Staff (LARSGESS)- excluding for shunters .

(3) Eligibility conditions prescribed for the wards of Driver/Loco Pilot under LARSGESS-1<sup>st</sup>.half- January-June,2012 are as follows.

## (4) <u>Mode of selection</u>

i) The suitability of the wards for recruitment under the scheme shall be adjudged by the assessment committee at headquarters level. Wards of willing and eligible Drivers/Loco Pilots shall be subjected to a written examination. Those qualifying in the written examination will have to undergo the 'Aptitude Test' as prescribed for direct recruitment of Assistant Loco Pilot (PB-1 ₹.5200-20200 GP ₹.1900). Candidates selected finally shall have to pass medical examination in prescribed medical classification before eligible for appointment as Assistant Loco Pilot.

ii) Wards shall be considered for appointment to the recruitment grade of Assistant Loco Pilot in PB-1, ₹. 5200-20200 GP: ₹. 1900/- only

Note: The post of Assistant Loco Pilot is not identified for persons with disabilities. Hence, persons with physical disabilities shall not be eligible to apply for the above post

#### How to Apply:-

- 6.1 The staff belonging to the above safety categories fulfilling the eligibility criteria and seeking retirement and employment to a suitable ward under this scheme during the year 2012(1<sup>st</sup> half-January- June 2012), should submit the application in the format annexed at Annexure-'1' to this Notification to concerned Sr. Divisional Personnel Officer/APO(M) by 20<sup>th</sup> .February,2012 through their supervisors.
- 6.2 Attested copies of certificates in support of age, academic/technical qualifications, caste etc. of the ward for whom employment is sought must be attached together with the application.

It is requested that wide publicity may be given to this notification at all levels, including the new crew booking lobbies and sub-divisional units under AOM,AMEE & AEE so that willing employees belonging to the above categories may submit their application for consideration under this Scheme.

Sr.DPOs concerned will ensure that the applications received are be scrutinized/verified properly duly certified by APO/DPO concerned with reference to the eligibility norms prescribed both for the serving employees belonging to the aforesaid category and their wards for which employment is sought under the Scheme and prepare a list of eligible candidates and publish the list in web site by 31.03.2012 and forward the applications along with a list of eligible candidates to this office by **01.04.2012** positively.

It is also requested that the time schedule prescribed under Para (5) above is strictly adhered to.
