- 1.VACANCIES: Men 07. Women 03. 2. CONDITIONS OF ELIGIBILITY:
- (a) Nationality: Must be an Indian.
- (b) Age Limit: 21 to 27 years (Born not earlier than 02 Jan 86 and not later than 01 Jan 92.
- (c) Educational Qualification: Minimum 55% aggregate marks in LLB Degree (three years professional after graduation or five years after 10+2 examination). The candidates should be eligible for registration with Bar Council of India/State.
- (d) Physical Standards:

(i) **Hight & Weight**: The minimum acceptable height and weight for men is 157.5 cms with correlated weight and for women candidate is 152 cm and 42 kg. In case of candidates belonging to the North East and hilly areas like Gorkhas, Nepalese, Assamese and Garhwalls, the height will be relaxed by 5 cms and weight commensurate with reduced height. In case of candidates from Lakshadweep, the minimum acceptable height can be reduced by 2cms.

(ii) Visual Standards: The minimum acceptable visual acuity are: Distant vision (corrected) better eye 6/6, worse 6/18, Myopia of not more than minus 3.5 including Astigmation. Candidates who have undergone or have evidence for having undergone Radial Karatotomy to improve the visual acuity will be permanently rejected. Candidates who have undergone Lasik Surgery for correction of reflective error are NOT acceptable.

(iii) To be passed fit, a candidate must be in good physical and mental health free from any disability likely to interfere with the efficient performance of duty.

(iv) Prospective candidates are advised to excercise and keep themselves physically fit, in order to avoid any injury due to the rigorous physical training at OTA Chennai. In order to be able to adjust to the regime there candidates are advised to achieve following standards before joining the OTA, if finally selected: (a) Running 2.4 Km in 15 minutes. (b) Push up - 13 Nos. (c) Sit ups - 25 Nos. (d) Chin ups- 6 Nos. (e) Rope climbing - 3-4 meter.

Note:- Candidates withdrawn from IMA/OTA/Naval Academy/Air Force Academy on disciplinary ground are not eligible to apply.

3. METHOD OF SELECTION: The Selection process to be followed is indicated below:

(a) Inital Screening and shortlisting of applications will be done at Recruiting Directorate Army Headquarters and the decision of ADG Recruiting will be final. In this regard no representation will be entertained. (b) candidates whose applications are found in order shall be detailed to appear at the Service Selecation Board on a specified date where they will be required to undergo Group Tests. Psychological Tests and an interview for duration of five days excluding the date of reporting at the Service Selecation Centre. (c) Two Stage Selection Procedure: Two stage selection procedure based on psychological Aptitude Test is held at Selection Centres. All the candidates will face stage one test on first day of reporting at Selection Centres. The candidates who qualify in stage one will be admitted to the second stage/remaining tests. Those who fail to pass stage one will be returned on the same date. (d) Those candidates who qualify stage II will submit the attested photo copy each of (i) Matriculation Certificate showing date of birth. (ii) Original degree or prov degree with all year/parts /semesters marksheets at Selection centre. (e) The candidates who qualify at the Service Selection Board and are found medically fit by a Medical Board, will be placed in order of merit. The final selection will be made in that order up to the number of vacancies available at that time.

5. The merit list of the recommended candidates will be displayed at the reception of ADG RTG and Indian Army Website i.e. www.joinindianarmy.nic.in.

6. MEDICAL EXAMINATION: A candidate recommended by the Service Selection Board will undergo a medical examination by a Board of Service Medica Officers. Women candidate will undergo Medical Examination by a Medical Board comprising male/female doctors/specialisty/gnecologist. There will be a Lady Medical Officer as member of the board. The proceedings of the Medical Board are confidential and will not be divulged to anyone. However, candidates declared unfit will be intimated by the president of the Special Medical Board (SMB) the procedure for request for Appeal Medical Board (AMB). Unfit Candidates should report for AMB within a maximum period of 42 days. Candidates are advised in their own interest to appear for AMB well in time and should not wait for the last date given by the SMB. Candidates are advised to note that Recruiting Directorate has no role to play in Appeal Medical Boards and procedure advised by the medical authorities is strictly to be adhered to. Candidates declared unfit by AMB will be intimated by the President, AMB about procedure to challenge the finding of AMB. Candidates will also be intimated that Review Medical Board (RMB) will be granted at the discretion of DGAFMS based on the merits of the case and that RMB is not a matter of right. Candidates will be considered medically fit only on receipt of the approved Medical documents from Directorate General Medical Services in Addl Dte Gen Rtg. (b) Pregnancy, if detected at any stage, after selection at SSB or during training will debar the candidate from grant of commission.

7. TRAINING AND PROSPECTS: (a) Selected candiates will be detailed for training at Officers' Training Academy, Chennai according to their position in the final order of merit, upto the number of vacancies available at the time (b) Duration of training - 49 weeks (approximately 11 months) training at OTA, Chennai, on successful completion of which candidates will be granted commission in the rank of Lt. No ante date seniority will be granted. (c) Candidates will neither be allowed to marry during the period of training nor will He/She be allowed to live with parents/ Guardians. Candidates must not marry until they complete the full training at the Officers Training Academy. A candidate, who married subsequent to the date of his/her application though successful at the Services Selection Board interview or medical examination, will not be inducted for taining. A candidate if he/she marries, while under training, shall be discharged and will be liable to refund all expenditure incurred on him/her by the government. (d) Training at OTA is at Govt. expense All candidates who successfully complete Pre-Commission training at Officers Training Academy, Chennai will be awarded "Post Graduate Diploma in Defence Management and Strategic Studies" by University of Madras.

8. SUITABILITY TO RETAIN SHORT SERVICE COMMISSION: If an Officer is reported upon within a period of six months from the date of confirmation of Short Service Commission as unsuitable to retain his commission, his commission may be terminated at any time, whether before or after the above perioed.

9. LIABILITY OF SERVICE: Officers granted Short Service Commission are liable to serve anywhere in India and abroad.

10. TENURE OF ENGAGEMENT: Short Service Commision to Officers (Male and Female) in the regular Army will be granted for 14 years i.e. for an initial period of 10 years extendable by a further period of 04 years. Officers who are willing to continue to servie in the Army after the expiry of period of ten years in Short Service Commission may, if eligible and suitable in all respects, be considered for the grant of permanent commission in the 10th years of their Short Service Commission in accordance with the relevant rules. Those SSC officers who are not selected for grant of PC but are otherwise considered fit and suitable, will be given options to continue as SSCOs for a total period of 14 years (including the initial tenure of 10 years) on expiry of which they will be released from the Army.

Important Note: (a) Candidates who submit more than one application will be disqualified for this course as well as from applying for commission in the Army in tuture. COST TO COMPANY (CTC) The CTC for a Lieutenant would be approxmiately 65000/- per month. This includes Basic Pay, DA, Grade Pay, Military Service v, Tech Pay, House Rent Allowance and Transport Allowance. These rates are statutory and are subject to change.

14. **PRIVILEGES.** In addition to the CTC mentioned above, Army provides free Medical facilities for Self & dependants, Canteen facilities, Entitled Ration, Mess/ Club/Sports facilities, Furnished Govt Accommodation, Car/Housing Loan at subsidised

15. GROUP INSURANCE AND GRATUITY. The Gentleman cadets of OTA in reciept of stipend are ensured for Rs. 40 lac w.e.f. 01 Apr 2011. Those who get medically boarded out of Academy on account of disability, the disability cover provided for 100% disability will be Rs. 20 lac which is proportionately reduced upto Rs. 4 lac for 20% disability.
