The University offers unique five year integrated undergraduate programs i.e. **B.B.A., LL.B. (Hons.)**; **B.A., LL.B. (Hons.)**; **B.Sc., LL.B. (Hons.)** to generate intensively trained global legal professionals. These integrated programs

offer unique and highly demanding honors courses in various facets of Law such as Constitutional Law, Business Law, Trade Law, International Law, Criminal Law and Intellectual Property Rights Law. **B.B.A, LL.B. (Hons.)** provides an integrated understanding of the interrelationship between management studies and law in their entirety. **B.Sc., LL.B. (Hons.)** inculcates requisite knowledge of contemporary technologies thereby establishing the groundwork for handling techno-legal disputes and IPR issues efficiently. **B.A., LL.B. (Hons.)** courses have been selected and structured to add further value to the law courses alongside providing an in-depth knowledge of public policy and analysis to the students.

The University's two year **LL.M.** programs in **Corporate Laws** and **IPR & Technology Laws** aims to harness young talent for achieving the pinnacle of legal perfection. The University also offers LLD and PhD programs in the quest for attaining excellence in higher education.

Price International Media Law Moot Court Competition**, 2011. In the **Queensland Maritime Arbitration Moot**, our team received the Sarah Derrington Achievement for their exceptional performance and was awarded for Third Best Respondent Memorial and the Fourth Best Claimant Memorial. In the **3rd ICC Trial Moot Court Competition**, our team was adjudged 6th overall and were declared the Best Victims Counsel. In the **ELSA WTO Moot Court Competition**, 2011 our team was awarded Best Memorandum Overall and Best Claimant's Memorandum. We received an Honorable Mention for Respondent Memorial in **Willem C. Vis (East) International Commercial Arbitration Moot, Hong Kong**, 2012. Our team won the Runners-Up Team Award in **Manfred Lachs Space Law Moot Court Competition** (Asia Pacific Rounds). Our student Vatsal Vasudev won a UN essay writing competition on the theme of "Rights and responsibilities of citizens in an interdependent world." NLUJ students have been awarded prestigious and meritorious scholarships like DAAD (German Academy Exchange Service) and Microsoft IPR scholarship etc.

NLUJ students and Faculty have a well groomed research temperament and publish regularly in journals of national and international repute. The University also encourages quality publications and wide dissemination of ideas through its many publications. **NLUJ Law Review** is the flagship journal of NLUJ. It has been established with the objective of becoming a formidable instrument in taking the standard of legal research in India up by several notches. It is a bi-annual, student-edited journal focusing on an inter-disciplinary approach towards legal writing. **TL&D (Trade, Law & Development)** publishes original works from a diverse and distinguished pool of authors, comprising, inter alia, scholars, practitioners, and students. Committed to improving access to research, TL&D is also a signatory to the Budapest Open Access Initiative and is indexed on the PKP-Open Archives Harvester2 archive. The **Indian Journal of Arbitration Law (IJAL)** is a forum for reflective writings on the theory and practice of International Arbitration by keeping abreast of the cutting edge research being done by the scholars in this field. It is an open access bi-annual publication providing timely insights useful to the international arbitration community. NLUJ has launched the **NLUJ Working Paper Series and Faculty Seminar** series with the objective to bolster the culture of legal research in national law schools in India. Our students have also brought laurels to the University by publication of Law books under the aegis of prestigious national and international publishers.

Mooting, a very intrinsic part of life in law schools, is given topmost priority at National Law University, Jodhpur. It is not only a part of the curriculum but also the academic system within the University. As a part of the academic structure, mooting at the primary level starts with Court Room Exercises, then moves on to Intra University Moot Court Competition whose ranking becomes the basis of allotment for participation in national and

international moot court competitions. To harness and optimize mooting skills, the university also organizes the prestigious **Antitrust Law Moot Court Competition** annually in association with Amarchand & Mangaldas & Suresh A. Shroff & Co. under the patronage of Competition Commission of India.

NLUJ has a well-structured internship program. The students go for internship with NGOs, Senior Advocates, Judges of Supreme Court and High Courts, SEBI, National and International law firms, Corporate Houses, Permanent Court of Arbitration at WTO in Geneva. NLUJ boasts of 100% campus recruitment for all batches since its inception. Placement starts one year prior to passing out of the students and many students bag favorable Pre-Placement offers in reputed organizations. The average package for the year 2012 was 12.5 lakhs. Students also go for judicial clerkship to Supreme Court. Our alumni have also been performing remarkably well. Shashank P. Kumar of Class of 2010 has become the first Indian to join the **International Court of Justice** as a Law Clerk. NLUJ students are admitted to prestigious Universities in USA like Yale, Washington, Colombia; in UK, to Oxford, Cambridge, as also in Germany and other countries for Post Graduate and Doctoral degrees. Workshops are organized by prestigious International and National Law Firms for the students on market intensive subjects. Continuous and extensive corporate training and exposure is given to the students by organization of Colloquiums, workshops, seminars, symposiums and round table discussions. Recently **Amarchand & Mangaldas** conducted a workshop on **Mergers & Acquisitions**, **SEBI** organized a one week **Securities Law Colloquium**, **WTO** conducted a workshop on **Dispute Resolution** and there was a Workshop on **Due Diligence** by **Vaish Associates**. Corporate training helps not only in knowledge enhancement in areas of contemporary relevance but also prepares the students for excellent placement.

NLUJ is equipped with distinguished Professors of national repute with a good mix of highly qualified and experienced young associates. A number of our Faculty members are alumnus from Universities of California, Oxford, Warwick, Sydney, King's College, London; University College, London; with working experience in foreign Law schools and International Institutions. The faculty also includes Scholars of Fulbright and other Institutions. In addition NLUJ invites distinguished Professors as visiting faculty for lectures. During the present semester, Faculty from Tokyo University, Pennsylvania, Oxford delivered informative lectures to our students. Under the NLUJ Alumni Visiting Faculty Program, some of our alumni who have acquired higher qualifications from prestigious Institutions and garnered varied experience share their learning on topics of Contemporary interest in law and practice for the benefit of the students. The Vice-Chancellor **Justice N.N.Mathur** provides meaningful inputs in exposing students to practical facets of law. He is Visiting Professor at Ural State Law Academy, Russia.



NLUJ, with a view to facilitate students in the understanding of the intricacies of legal research, corporate work culture and develop an insight in alternative forms of learning on academic and corporate subjects, has established Centers of excellence; namely Research and Advisory Centre on International Economic Law, Centre for Studies in Banking and Financial Institutions, Centre for Human Rights Education and Research, Centre for Human Welfare and Empowerment, Centre for studies in Taxation, Centre for Governance, Centre for Legal Aid and Support Services, Centre for Research on Transactional law and Practice. MHRD has established an IPR chair to promote teaching and research in IPR. Our students also undertake consultation and research work; Aritra Roy of IX Semester was involved in a research project with Prof. Phillip Wood, QC, Global Counsel, **Allen & Overy**, LLP on the World Universities Comparative Law Project: Legal risk rating of India.

NLUJ has signed MoUs with universities in U.S.A, U.K, Russia, China and Germany for student and faculty exchange program. We have recently signed a MoU with Chartered Institute of Arbitrators to promote in-depth study of arbitral nuances. The modalities of international collaborative dual degree programs at LLM and PhD level are being workout.

NLUJ is a sprawling green, beautiful, well equipped campus in semi desert area encompassing 55 acres of land located on the outskirts of the city of Jodhpur. The campus has all the trappings of comfort and amenities to foster a conducive learning atmosphere. The entire campus, including HoR, have wireless connectivity whereby the students and the faculty can access internet services from anywhere in the campus.
