ELIGIBILITY CONDITIONS FOR 5 YEARS B A. LL.B COURSE: -

A Candidate seeking admission to 5 year B.A LL.B course should have passed an examination in 10 + 2 course of schooling recognized by the educational authorities of Central/State Government or possess academic qualifications which are considered equivalent to 10+2 courses by the Bar Council

of India and should have obtained 45% of Marks in aggregate in the 10+2 examination in case of general candidates and 40% of marks in case of SC/ST and Cat-I candidates.

The candidate applying for merit seats in Karnataka quota must have studied for 7 academic years in Karnataka and must produce a certificate to that effect.
