4. GENERAL INFORMATION:-

- A. The rule of reservation of appointments is applicable to each post /District Unit in respect of post of Revenue Assistant in Revenue Department separately. **The Unit wise distribution of vacancies as per rules will be announced later.**
- B. In G.O. (Ms.) No.145, Personnel and Administrative Reforms (S) Department, dated 30.09.2010, and G.O.(Ms.)No.40 Personnel and Administrative Reforms(S) Department dated 30.04.2014 the Government have issued orders to fill up 20% of all vacancies in Direct Recruitment on preferential basis to persons who studied the **prescribed qualification** in Tamil Medium. The 20% reservation of vacancies on preferential allotment to **Persons Studied in Tamil Medium (PSTM)** will apply for this recruitment. . (Candidates claiming this reservation should have studied the prescribed qualification for the post in Tamil Medium and should have the certificate for the same. Having written the examinations in Tamil language alone will not qualify for claiming this reservation). If the candidates with PSTM are not available for selection for appointment against reserved turn such turn shall be filled up by Non-PSTM candidates but belonging to the respective communal category. The PSTM reservation certificate, shall be produced / uploaded by the candidate as it has been in prescribed format / proforma available in the Commission's website at 'www.tnpsc.gov.in' which shall be obtained from the Head of the Institution.

- C. The number of vacancies advertised is only approximate and is liable to modification with reference to vacancy position at any time before finalisation of selection for Oral Test.
- D. Correct and true information regarding arrest, convictions / debarment / disqualification by any recruiting agency, criminal or any disciplinary proceedings initiated or finalised, participation in agitation or any Political Organisation, candidature in election for Parliament / State Legislature / Local Bodies etc, if any, should also be furnished to the Commission at the time of application i.e. the details thereof, originals of the judgement of Acquittals, order/ or G.O. Dropping further action in Departmental proceedings or any document that may prove the suitability of such candidates for a Government appointment in such cases must be produced at the stage / time of certificate verification.
- E. The selection for appointment to the above said posts is purely provisional subject to final orders on pending Writ Petitions, if any, filed in Madras High Court and High Court of Madurai Bench.

- F. If no qualified and suitable women candidates are available for selection against the vacancies reserved for them, those vacancies will be filled by male candidates belonging to the respective communal categories.
- G. 10% of vacancies out of 30% of vacancies set apart for Women candidates in direct recruitment are reserved for Destitute Widows in respect of the posts for which the scale of pay does not exceed Rs. 5200-20200 + Grade Pay 2800/- (PB 1). The G.O. regarding definition of Destitute Widow is available as Annexure-III of this Notification.
- H. 5% of vacancies shall be set apart for Ex-Servicemen in the posts which are classified under Group-'C' (i.e.,) with the Grade Pay minimum of which Rs.1,400/- and above but below Rs.4,400/-. If no qualified and suitable Ex-Servicemen belonging to a particular category is available for selection for appointment against reserved turn, such turn shall be filled up by a candidate other than Ex-Servicemen but belonging to the particular communal category. The G.O. regarding definition of Ex-Serviceman is available as Annexure-IV.
- I. 3% reservation for Differently Abled person is applicable for this recruitment except for the posts of Junior Employment Officer (Non-DA) and Assistant Inspector of Labour. If no suitable DA candidate belonging to the respective category to which it is earmarked is available for selection, it will be carried forward to next recruitment. The G.O. regarding Differently Abled is available as Annexure-V of this Notification.

Candidates with defective vision should produce eye fitness certificate from qualified eye Specialist.

- K. The Differently Abled persons should produce a certificate of physical fitness from the Medical Board to the effect that his/her handicap will not render him/her incapable of efficiently discharging the duties attached to the post to which he/she has been selected, before appointment. Percentage of disability should be specifically mentioned.
- L. Even after filling up of the posts reserved for SC (Arunthathiyars) on preferential basis, if more number of qualified Arunthathiyars are available, they shall be entitled to compete with the Scheduled Castes other than Arunthathiyars in the inter-se-merit among them and if any posts reserved for Arunthathiyars remain unfilled for want of adequate number of qualified candidates, it shall be filled up by Scheduled Castes other than Arunthathiyars.
- M. Regarding the vacancies available in the Department of Hindu Religious and Charitable Endowments, only persons professing Hindu Religion are eligible.
- N. The original certificate for any claim relating to the selection (not related to candidature or / and claims made in the application) should be produced when called for. Any claim received thereafter will received no attention.
- O. **Applications containing wrong claims relating to other basic qualifications / eligibility age/ category of reservation / educational qualification will be liable for rejection.**

- a. Two types of question papers will be set. One type of question paper will contain questions on General Studies (75 items), Aptitude and Mental Ability Test (25 items) and General English (100 items). The other will contain questions on General Studies (75 items), Aptitude and Mental Ability Test (25 items) and General Tamil (100 items). Candidates are given the option to choose either General Tamil or General English for

answering the second 100 items apart from answering the first (75+25) 100 items on General Studies.

- b. The questions on General Studies will be set both in English and Tamil and the questions on General Tamil/ General English will be set in the respective languages.

ORDER

As per proviso of Rule 21 of the General Rules for the Tamil Nadu State and Subordinate Services, in the case of direct recruitment to the posts with Grade pay which does not exceed Rs.2400/-, ten percent of vacancies out of thirty percent vacancies set apart for women shall be set apart for destitute widows. In the Government order second read above, revised orders were issued among others enhancing the Grade pay attached to the post of Assistant in all Government departments from Rs.2400/- to 2800/-.

2. In the letter third read above, the Secretary, Tamil Nadu Public Service Commission has informed that reservation for Destitute Widow has to be extended to the posts for which the Grade pay has been enhanced from Rs.2400/- to 2800/- as per the orders issued in Government Order second read above, and the reservation for Destitute Widow has been announced in the Tamil Nadu Public Service Commission notification and requested that necessary executive orders giving effect from 01.01.2006 may be issued so as to validate the notification issued on 30.12.2010.

3. The Government have examined the request of the Secretary, Tamil Nadu Public Service Commission in detail and have decided to issue necessary amendment to the proviso to Rule 21 of General Rules of Tamil Nadu State and Subordinate Services.

4. Accordingly, the following Notification will be published in the Tamil Nadu Government Gazette :-

NOTIFICATION.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the General Rules in Part II of the Tamil Nadu State and Subordinate Services Rules (Volume I of the Tamil Nadu Services Manual, 1987).

5. The amendment hereby made shall be deemed to have come into force on the 1st January 2006.

AMENDMENT.

In the said Rules, in rule 21, in the proviso to sub-rule (b), for the expression "Rs. 2400/-", the expression "Rs. 2800/-" shall be substituted.

ORDER:

Ever since the orders defining the term "Ex-servicemen" issued in the Government Order first read above, there have been several changes and clarifications issued to the term "Ex-servicemen". It has also been noticed that in certain Government Departments, the old form of definition is still being followed which results in denial of concessions/facilities to the genuine Ex-servicemen and some ineligible persons who do not come under the definition get the benefits extended to Ex-servicemen. Hence it is considered necessary to issue consolidated orders for defining "Ex-servicemen" incorporating all the amendments/clarifications issued so far in this regard.

2. Accordingly, the Government direct that the following definitions be made applicable to personnel who retired on or before 30.06.1968, between 01.07.1968 and 30.06.1979 (both days included), between 01.07.1979 and 30.06.87 (both days included) and on or after 1.07.1987. The Departments of Secretariat are directed to make necessary amendment in their respective rules accordingly.

Any person who had served in any rank (whether as Combatant or not) in the Armed Forces of the Union for a continuous period of not less than six months after attestation and released therefrom otherwise than by way of dismissal or discharge on account of misconduct or inefficiency.

- (iii) Those released between 01.07.79 and 30.06.87 (both days included):

Any person who had served in any rank (whether as Combatant or not) in the Armed Forces of the Union for a continuous period of not less than six months after attestation if discharged for reasons other than at their own request or by way of dismissal or discharged on account of misconduct or inefficiency and not less than 5 years of service if discharged at his own request.

- (iv) Those released on or after 01.07.87:

Any person who had served in any rank (whether as Combatant or not) in the Armed Forces of the Indian Union and was released/retired with any kind of pension from Defence Budget or released on completion of specific terms of engagement with gratuity otherwise than at his own request or by way of dismissal or discharge on account of misconduct or inefficiency.

- (v) The personnel of Territorial Army (TA) of the following categories viz. pension holders for continuous embodied service persons with disability attributable to military service and gallantry award winners retired on or after 15.11.86.

2. The personnel of the Army Postal Service (APS) who are a part of the Regular Army and retire from such service. (i.e. directly from the Army Postal Service itself without reversion to P&T Department) with pension or who have been released from such service on medical grounds attributable to military service or circumstances beyond their control and awarded medical or other disability pension are also covered within the definition of Ex-Servicemen with effect from 19.07.89.

In the Government Order first-read above, orders have been issued to the effect that five percent of vacancies shall be set apart for Ex-servicemen in the posts which are classified in Group 'C' in the State Government Service following the rule of reservation.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the General Rules in Part II of the Tamil Nadu State and Subordinate Services Rules (in Volume I of the Tamil Nadu Services Manual 1987).

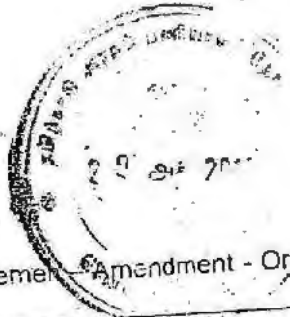

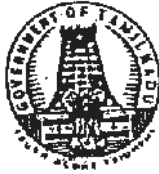

ORDER :-

In the G.O. first read above, the Government issued orders reserving 3% of vacancies in all state Public Services / Educational Institutions under all kinds of Managements (like Government, local bodies and aided Managements including Universities) for Physically handicapped persons in the posts where the rule of reservation is applicable for the Scheduled Caste/Scheduled Tribes and Backward Classes and other communities. In the G.O. second read above, Rule 22 of the General Rules for the Tamil Nadu State and Subordinate Services has been amended to the above effect. In the G.O., third read above, the Government have ordered that the reservation of 3% vacancies for the physically handicapped persons should be made applicable to the Executive posts in respect of C & D categories . It was also ordered therein that in respect of Executive posts under A & B categories no reservation need be made to physically handicapped persons and that the reservation of 3%

vacancies for physically handicapped persons need not be made applicable in the case of recruitment by transfer/promotion. As per the G.O. fourth read above, 3% of the quota reserved for physically handicapped persons should be made as indicated below:

S. No.	Category of the Handicapped	Percentage of reservation
1	Blind	1%
2	Deaf	1%
3	Orthopaedically Handicapped	1%

2. The Government of India in its Memorandum Fifth read above gave instructions to all the Ministries and Depts. that with the enactment of the Persons with Disabilities (Equal opportunities, protection of Rights and Full Participation) Act, 1995 the reservation to physically handicapped stood extended to identified groups 'A' and 'B' posts filled through Direct Recruitment.

3. In the letters Sixth read above the Director of Rehabilitation of the Disabled requested the Government to issue a notification by ordering a reservation of 'A' and 'B' posts for the benefit of disabled persons. The Director recommended for the constitution of an expert Committee to identify the posts which can be suitable for the disabled persons.

4. In the G.O. Seventh read above the Government constituted an Expert Committee to identify certain posts under A and B groups. The Expert Committee submitted its report. In the G.O. Eighth read above the Government constituted another committee to examine further the report furnished by the Expert Committee. The State Special Commissioner for the Disabled subsequently was requested to identify most suitable posts from out of the posts already identified in consultation with concerned H.O.Ds. In his letter 9th read above the State Special Commissioner for the Disabled has furnished a finalised list of 117 posts most suitable for the disabled persons under A & B groups.

5. The Hon'ble Chief Minister has announced on the floor of the Assembly under Rule 110 of the Assembly rules on 16-03-2005 that the Government have identified 117 types of posts which are the most suitable posts for the disabled in 'A' and 'B' groups of posts; that the Government will notify the list in the Gazette and that during the recruitment, 3% of the posts will be reserved for the disabled.

6. Based on the announcement made by the Hon'ble Chief Minister the Government approve the list of 117 posts identified under group A & B categories under the purview of Teachers Recruitment Board and the TNPSC for the persons with disabilities. The Government also direct that 3% of the vacancies in direct recruitment for the identified posts of A and B groups, where the rule of reservation is applicable for the SCs/STs, B.Cs and other communities, shall be reserved for the disabled persons. If only one post is available for recruitment in these categories, the usual procedure for

recruitment will be followed. In so far as Executive posts are concerned the individual shall produce a certificate of physical fitness from the Medical Board to the effect that their handicap will not affect the performance of the job to which he/she has been selected, before appointment.

7. The list of the 117 categories of posts identified as most suitable for the different categories of the disabled persons in A and B groups in Direct Recruitment is given in the Annexure to this order.

8. The Guidelines issued for the reservation of 3 percent for the Disabled persons in para 3 of the G.O. first read above will be made applicable to the 3% reservation ordered in paras 5 and 6 above. Deleted as ordered in C.O. no. 213, SW + RSP, Dept. dt. 15-9-05

8. Necessary amendment to Rule 22 of the General Rules for Tamil Nadu State and Subordinate Services shall be issued separately by the Government in Personnel and Administrative Reforms Department.

ORDER:

In the Government Order first read above, the Government have issued orders for reserving 3% of vacancies in Government / Government aided Managements/ Local bodies, and Universities for differently abled persons where the rule of reservation is applicable for SC/ST's, BC and other communities.

2. In the Government Order second read above, the Government have ordered that the vacancies for differently abled persons should be made applicable to the executive posts in respect of Group 'C' & 'D' categories.

3. In the Government Order third read above, the Government have issued orders that 117 posts identified under Group A & B categories shall be reserved for differently abled persons.

4. In the Government Order fourth read above, the Government have ordered that a High Level Committee was constituted under the Chairmanship of Chief Secretary to monitor the implementation of 3% reservation for the Differently Abled Persons in all Government jobs.

5. In the letter fifth read above, the Principal Secretary/ State Commissioner for the Differently Abled has stated that as per Persons with Disabilities (Equal Opportunities, Protection of Rights and Full participation) Act 1995, Sec 32 appropriate Government shall,

- a) identify posts in the establishments which can be reserved for the Persons with Disabilities.
- b) at periodical intervals not exceeding three years, review the list of posts identified and update the list taking into consideration the developments in technology.

6. Further, he has stated that posts in Secretariat and posts in the Boards/ Undertaking were not identified. Since Government of India has identified even Civil Services as suitable for Differently Abled Persons, several Writ Petitions are being filed by Differently Abled Persons in the Hon'ble High Court of Madras against Tamil Nadu Public Service Commission notification in Group 'A' & 'B' posts by demanding 3% reservation for Differently Abled Persons. The Chief Secretary to Government has also instructed during the monitoring meeting on 20-12-2011 to identify more number of posts suitable for Differently Abled Persons.

7. Subsequently, the Principal Secretary/State Commissioner for the Differently Abled was requested to identify most suitable posts from out of the posts already identified in consultation with concerned Heads of the Department. In his letter fifth read above, the State Commissioner for the Differently Abled has furnished a finalized list of 170 posts most suitable for the differently abled persons under A and B groups with the help of Expert Committee .

8. After careful examination of his proposal of the Principal Secretary/ State Commissioner for the Differently Abled, the Government approve the list of 170 posts identified under group A & B categories under the purview of Tamil Nadu Public Service Commission for the Persons with Disabilities. The Government also direct that 3% of the vacancies in direct recruitment for the identified posts of A and B groups, where the rule of reservation is applicable for the SCs / STs, BCs and other communities, shall be reserved for the differently abled persons. If only one post is available for recruitment in these categories, the usual procedure for recruitment will be followed. In so far as Executive posts are concerned the individual shall produce a certificate of physical fitness from the Medical Board to the effect that their handicap will not affect the performance of the job to which he/she has been selected, before appointment.

9. The list of the 170 categories of posts identified as most suitable for the different categories of the differently abled persons in A and B groups in Direct Recruitment is given in the Annexure to this order.

10. The Guidelines issued for the reservation of 3 percent for the Differently Abled Persons in para 3 of the Government Order first read above will be made applicable to the 3% reservation ordered in para 8 above.

11. Necessary amendment to Rule 22 of the General Rules for Tamil Nadu State and Subordinate Services shall be issued separately by the Government in Personnel and Administrative Reforms Department .

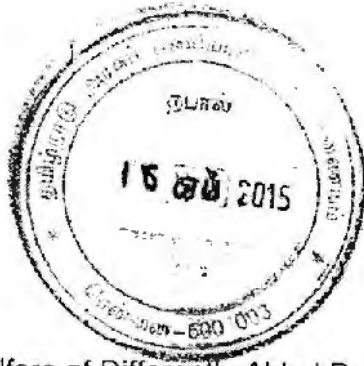
