# Revenue Inspector Syllabus and Exam Pattern:

Odisha Subordinate Service Selection Commission (OSSSC) is looking for the young talent and dynamic individuals. Candidates those applied for the Revenue Inspector Jobs have to qualify in three rounds to get a job. Candidates need to qualify in Physical Fitness Test which is the main test. Candidates qualified in this only are eligible for writing the written test. After the exam commission will shortlist the candidates for Computer Practical Test. Candidates qualifying this last and final round will be selected for the Revenue Inspector Jobs.

A Large number of candidate are waiting for the OSSSC Revenue Department notification. Now the candidates are seriously involved in preparation for the exam. Here we have provided detail information about the Revenue Inspector Exam Pattern and syllabus. OSSSC main aim is to recruit all Group-C Civil posts and Services in different districts offices of Odisha State under the governance of Government of Odisha. This year OSSSC has released a notification for 1756 vacancies. Eligible, talented, challenging and dynamic persons will be selected for the post of Assistant Revenue Inspector & Amin, Revenue Inspector posts.

## Physical Fitness Test:

To begin with, the shortlisted candidates shall have to appear a Physical Fitness Test. In order to qualify in this test, a candidate

1. If a male, must not be less than 160 centimeters (155 centimeters in case of SC/ST candidates) in height and 80 centimeters round the chest;
2. If a woman, must not be less than 150 centimeters (145 centimeters in case of SC/ST candidates) in height; and
3. Must be knowing cycling and swimming.

## OSSSC Revenue Inspector Exam Pattern:

The candidates who qualify in the test of physical fitness shall be eligible to appear a Written Test for 350 marks for the post of R.I. and 250 marks for the post of ARI and Amin.

**Note:** (i) The standard of examination shall be equivalent to that of Secondary School.

(ii) A candidate has to score minimum 30% marks in each subject both in written practical tests to qualify.

(iii) The lists of qualified candidates drawn up in order of merit on the basis of the performance in the written and computer tests shall be equal to the number of vacancies advertised.
