2. ADMISSION RULES

- A. Admission in the courses of **University Teaching Departments** shall be given by the Heads of the respective teaching departments on the basis of merit scored by the candidates out of their qualifying examinations.
- B. **Eligibility for LL.M. Two Year Post Graduate Degree Programme-** A candidate seeking admission in this programme shall need to have scored minimum 55 % marks in LL.B. Three Year/ LL.B. Five Year Integrated Programme. There is no upper or lower age limit.
- C. **Eligibility for M.A. in Functional Hindi-** A candidate seeking admission in this programme shall need to have earned his/ her Bachelor Degree with Hindi as one of the core papers or foundation paper with minimum second division.
- D. **Eligibility for M.Sc. in Bio-Technology-** A candidate seeking admission in this programme shall need to have earned Degree of B.Sc. Biology/ Biotechnology/ Biochemistry / Microbiology/ Agriculture. Or B.E./B. Tech. Biotech with minimum second division.
- E. **Eligibility for M.Sc. in Computer Science-** A candidate seeking admission in this programme shall need to have earned Degree of B.Sc. (CS) / B.Sc. (IT) / BCA with minimum second division.
- F. **Eligibility for M.Sc. in Environmental Science-** A candidate seeking admission in this programme shall need to have earned Degree of B.Sc..Envs./ B.Sc.. (Chem/Bot./Zoo) B E./B.Tech / M.B.B.S and allied subjects with minimum second division.
- G. **Eligibility for M.Sc. in Farm Forestry-** A candidate seeking admission in this programme shall need to have earned Degree of B.Sc. Forestry/ Agriculture/ B.Sc. Biology/ Biotechnology/ Biochemistry / Microbiology/ Agriculture with minimum second division.
- H. **Eligibility for Diploma in Pharmacy -** A candidate seeking admission in this programme shall need to have earned certificate of 12th in Maths /Biology with minimum second division.
- I. **Age limit for programmes mentioned in C to G-** The candidate should not have attained 27 years age on 01-07-2017. These age limits are relaxed up to three years in the case of Scheduled Caste/Scheduled Tribe/Backward Class/ Handicapped applicants/Female applicants.

- J. Those applicants who have been penalized by the University for adopting malpractice during University examinations shall not be given admission.
- K. Applicants against whom there are serious criminal or immoral charges or their cases are under examination or lying pending with the police department or the court of law, or those applicants who have created any nuisance in the examination, shall not be admitted as long as they do not pass the examination of that class.
- L. Only duly filled application forms shall be entertained and processed for preparation of merit list. Incomplete application forms shall be rejected summarily without assigning any reason to the candidates.
- M. **Reservation-** 12% seats for Scheduled Castes, 32% seats for Scheduled Tribes, 14% seats for Other Backward Classes and 3% seats for the Physically Handicapped are reserved (Except Physical Education). 3% seats for the dependents of the freedom fighters are reserved as per the rules of the Chhattisgarh State. If seats for the aforesaid categories are vacant, then they will be allotted to other eligible applicants. In all these categories 30% seats are reserved for women applicants. It is necessary to attach certificates from competent authority along with the application for reserved seats. (Note-Subject to change as per C.G. Government)
- N. The following concessions will be provided to the Kashmiri migrant students during the academic session 2017-18 (Ref.- Approved by the MHRD)
- i. Relaxation in cutoff percentage upto 10% subject to minimum eligibility requirement.
 - ii. Increase in intake capacity upto 5% course-wise.
 - iii. Reservation of at least one seat in merit quota in technical/ professional institutions.
 - iv. Waiving off domicile requirements.
- O. **Criteria of Selection- Selection of students will be as follows**
- i. Students holding Ist division in qualifying exam of this University.
 - ii. Students holding Ist division in qualifying exam from other Universities of Chhattisgarh.
 - iii. Students holding Ist division from outside state.
 - iv. Students holding IInd division as per above criteria of merit.

- v. Admission to post-graduate classes shall be given on the basis of merit, which is to be determined on the aggregate of marks of theory papers only.
- vi. Students having passed their graduation with first division are eligible for admission to post-graduate classes, however, their merit is to be decided on the basis of total marks obtained in the theory papers of the examinations required for eligibility according to the availability of seats.
- vii. Eligibility for admission in post-graduate classes is to be decided on the basis of order of merit. Their merit will be decided on the basis of total marks in the theory papers of the subject and allied subjects, as mentioned in respective ordinances in which they want to do the post - graduate course.
- viii. For admission to P.G. Course students, who have passed their graduation after 2006 is required to pass in the Environmental Studies as per Supreme Court guidelines.
- ix. University Teaching Departments are free to admit students by holding separate writing examination.
- x. University Teaching Departments are free to admit those students of other states who have obtained 75% or above marks in the qualifying examination by increasing upto 20% of the existing number of seats.
- xi. University Teaching Departments are free to admit those students of other countries who qualify the Eligibility for admission by increasing up to 20% then citing number of seats.

Note: *Any applicant desirous of seeking admission to such a subject at P.G. Level, for which he did not opt during the graduation level, might be admitted only after all students figuring in the above-said merit list has taken admission and seats are still vacant.*

While preparing the above said merit list relaxation of 5 % marks in the aggregate of theory papers shall be given to students belonging to SC/ST/OBC of Chhattisgarh state.

P. Weightage: While preparing the merit list "weightage" means that which is based on the percentage of marks. The weightage will be given on the following manner. However, weightage of more than one type will not be allowed.

N.C.C./N.S.S./Honours Subject:

i.	On the basis of “A” certificate at graduation level	2%
ii.	On the basis of “B” certificate at post-graduation level	2%
iii.	Students representing State level N.C.C. Directorial competition	3%
iv.	N.C.C. or N.S.S. students participating in Republic Day Parade in New Delhi	5%
v.	On the basis of 240 hours certified work experience in N.C.C.	3%
vi.	Students with Honours subject from Government Colleges/University seeking admission in the same subject in post-graduate class	10%
vii.	The son, daughter, husband, wife of a Teacher, Officer or Employees of Sarguja University	5%
viii.	Weightage for the handicapped	10%

Q. Special Encouragement:

- i. Applicant who has participated in Olympiad/ ASIAD/ sports competitions, organize by the Sports Authorities of India at national or international level shall be given admission despite the merit list in the stream for which he/she is eligible in the forthcoming academic session. Nevertheless, to gain the benefit of such concession again, he/she will have to join the above said qualification again.
- ii. Students who have participated in the sports competitions organized by the Association of Indian Universities, Department of Higher Education, Chhattisgarh State at State level and Directorate of Public Instructions, Government of Chhattisgarh and in inter-regional sports competitions organized by central schools /organizations to be given Weightage in the interim examinations as follows :
 - Gold Medal/ Standing first 20 %
 - Silver Medal/ Standing second 15 %

- Bronze Medal/ Standing third 12 %
 - For only participating 10 %
- iii. Students who have passed the last qualifying examination from any University other than Sarguja University has to submit the migration certificate within one month from the date of admission.
- iv. An applicant employed in any institution or office must submit a "no objection" certificate from his/ her employer that the employer has no objection to his taking admission to the teaching department and to continue education.
- v. **Interview:**Students (both boys/girls) who are willing to take admission to be present for an interview on their own (if called for) before the Head of the Department on scheduled date and time.
- vi. Total Seats: Seats are limited and admission will be given on fulfilling the conditions laid down by the UTD department.

R. Application for Admission:

1. Application for the admission to a program offered by the university will be available in print form (INR 350=00) or can be downloaded from the university website. Duly filled application form has to be submitted to the respective departments. Downloaded Application should be accompanied by a Demand Draft of Rs 350=00 payable to the Registrar, Sarguja University, Ambikapur, failing which the application will not be entertained.
2. The application should accompany following self attested document:-
 - a) Domicile Certificate & other weightage claim certificate.
 - b) Caste Certificate, wherever applicable.
 - c) Certificate showing date of birth.
 - d) Mark sheet/Certificate of all classes from 10th to qualifying examination.

3. DOCUMENT REQUIRED AT THE TIME OF ADMISSION:

- a) Transfer Certificate.
- b) Character Certificate.
- c) Original marksheet for verification.
- d) Eligibility Certificate, if required.
- e) Migration Certificate, if required.
- f) NOC from the Employer in case of in service candidate.

g) Gap certificate, if required.

S. MISCELLANEOUS:

- a) The Head of the concerned departments of the University Teaching reserves the right to deny admission to any applicant without showing cause against which nobody will have the right to take any legal action.
- b) No information about admission to the applicant shall be given individually. The list of students selected for admission shall be displayed in the notice board of the UTD concerned/website. Students have to collect information about their admission on their own. If the admission fee is not deposited on or before the date of admission given in the notice board the admission allowed shall be cancelled.
- c) Information given by the applicant in the application form should be absolutely true. If any information is suppressed or any false information is submitted by the applicant, his/ her admission shall be cancelled and, if necessary, the applicant shall be expelled from the UTD.
- d) The University reserves the absolute right to change/ modify any of the rules mentioned in the prospectus and all orders and directions promulgated in the notification shall be equally binding on the students.

T. SPECIAL:

An admitted student in any programme running in the UTD cannot study as a regular student in one course and as a private student in the other course nor can appear in the separate examinations.

U. Cancellation of Names from the List:

Names from the list of students shall be crossed out due to following reasons:

- a) if the conduct of the students in the department is not good,
- b) if his/ her progress in studies is not satisfactory, and
- c) if Head of the concerned department deems it fit to cancel his/ her name.

V. Attendance:

For appearing in an examination of the Sarguja University, 75% Attendance in classes is compulsory in all subjects separately, with both theory and practical. 75% Attendance in each shall be required.

W. Blood Group:

Students are required to furnish information on their respective blood group before taking admission in any University Teaching Department.

X. Change of Subject:

If a student wants to change his/her admission amongst University's Teaching Departments he/she has to proceed on or before the closing of admission date, with permission from both the old and new departments. But any such interdepartmental subject change cannot be possible after 14 August.

Y. Other Information

- a) **SESSION.** The current academic session shall commence from 15.07.2017.
- b) **MEDIUM OF INSTRUCTION AND EXAMINATION.** The medium of instruction and examination will be Hindi/ English.
- c) **IDENTITY CARD.** It is necessary for every admitted student of the UTD to keep the identity card. It must be with them during the time of any meeting, conference and the working hours of their departments. The identity card can be availed from the Head of the concerned Department of the UTD and be attested by the Proctor.
- d) **EXTRA-CURRICULAR ACTIVITIES.** There is provision for extra-curricular and other activities in the UTD for the all round development of the students.
- e) **STUDY HOURS IN THE UNIVERSITY SCHOOL OF STUDIES.** The working hour of UTD shall be normally from 10:30 a.m. to 5:30 p.m. In special circumstances the time schedule of a Department can be changed at the discretion of the concerned Head subject to approval from the Registrar. Information regarding time schedule shall be provided by the Head of the UTD concerned, which, however, must be personally collected by the students themselves.
- f) **N.S.S.** The National Service Scheme (NSS) unit functions in the UTD of the University under which 75% students shall be recruited. Those students who have completed 240 hours of NSS work in course of two years and the University has issued certificates to them, their eligibility for admission shall be

determined by adding 3% bonus marks to the total marks they have actually obtained in the qualifying examination.

- a) **CELLS FOR GRIVEANCE/ HARASSMENT PROBLEMS/PLACEMENT CELL.** Separate Cells exist to deal with the complains made by the students studying in the UTD related to the grievance, discipline and Female harassment.
- b) **IQAC.** An internal quality assurance cell functions in the University. The quality of teaching, research and administration is monitored as per the requirement of NAAC.

6. DETAILS OF UNIVERSITY TEACHING DEPARTMENTS

I. DEPARTMENT OF BIOTECHNOLOGY

The Department of Biotechnology of this university was established in the year 2011 with an aim to cultivate the habit of innovative, independent thinking and problem solving, students/ scholars in the most advanced field of Biotechnology in Surguja zone of Chhattisgarh, India. The department has nationally and internationally experienced and trained faculty to impart knowledge in the various specialized advanced fields of Biotechnology. The Department is committed to provide quality Scientific and Technical education and to equip its students with Biotechnological skills, making them resourceful in the various most advanced areas of Biotechnology. At present the Department is offering M.Sc. two year (4 Semesters) Biotechnology course with a sanctioned intake of 20 students per year and shortly going to start Ph.D. program. Till the date three batches have been passed out and the budding biotechnologists of the department are serving their purposes in different sectors of intellectual society. The major areas of research in the Department include Plant Genetics, Molecular Biology, Functional Genomics, and Plant Biotechnology and Infectious diseases.

The Department of Biotechnology offers 2 years (4 semesters) M.Sc. Biotechnology course with a sanctioned intake of 20 students per year. In the departmental curriculum, Choice Based Credit System (CBCS) has been applied as per UGC-New Delhi norms, to provide our students high quality biotechnology education with an innovative core and specialized biotechnology subject units together with practical skills. During the fourth semester, students have to undertake a full time project work in any recognized Biotech laboratories/institutes/university of national and international repute in India.

- To develop motivated professionals for facing global challenges in the field of Biotechnology and to create awareness among the society to harness the benefits of modern Biotechnological innovations.

Facilities available in the department

- The department has excellent facilities viz.
