- * The rate of stipend may vary on the basis of minimum wages amended from time to time prescribed by Dy. Chief Labour Commissioner (Central).
- ** The stipend rates may vary from time to time subject to any amendments prescribed by Deendayal Port Trust or Board of Apprenticeship Training (WR).

Age & Qualification criteria:

The applications will be considered in respect of those candidates who fulfill the following criteria:

- Age: Below 28 years (as on 30.09.2018) in respect of any of the trades / disciplines mentioned above.
- For Sr. No. 1 to 9: The candidates should have passed the respective trade from ITI in the year 2013 or thereafter.
- For Sr. No. 10 to 13: The candidates should have passed the final examination of Diploma in Engineering in respective trade (on regular basis) in the year 2016 or thereafter.
- For Sr. No. 14 to 17: The candidates should have passed the final examination of Degree in Engineering in respective trade (on regular basis) in the year 2016 or thereafter.

Note:

- (i) The selected candidates will have to execute necessary contracts to be registered with RDAT & BOAT mandatorily, as the case may be, under the Apprentices Act, 1961 as amended from time to time, failing which, DPT may cancel the candidature for apprenticeship training without giving any reason.
- (ii) All ITI qualifications should be recognized by NCVT or State Council of Vocational Training Board.
- (iii) All Diploma Engineering qualifications should be granted by a State Board of Technical Education, or recognized by the State Government concerned or the Central Government.
- (iv) All Engineering Graduate shall
 - (a) hold a degree in engineering or technology granted by a statutory University, or an institution empowered to grant such degree by an Act of Parliament;
 - (b) has passed the graduate ship examination of professional bodies recognized by the Central Government as equivalent to degree; OR
 - (c) holds the qualifications which exempt him from Sections A and B examinations of the Institution of Engineers (India).
- (v) Candidates applying for any of the trades / disciplines mentioned above should not have undergone or should not be undergoing apprenticeship training in the past.

- (vi) Candidates who have already undergone or are currently working in any Government / Public sector / Private organization are not eligible to apply.
- (vii) Candidates should possess a valid E-mail ID and mobile phone no.

Selection Criteria:

- Eligible candidates will be provisionally selected on merit basis. The merit will be prepared on the basis of 'Sum of marks obtained in all semesters / years' and 'Sum of total (maximum) marks in all semesters / years' [as declared by the candidate while filling the application form on DPT website – www.deendayalport.gov.in].
- Candidate will him / her self be held responsible with regard to the correctness of marks / details declared while filling the application form on DPT website – www.deendayalport.gov.in.

No correspondence will be entertained / no communication will be made with reference to the incorrect or false details provided by candidate.

- The merit list (s) will be uploaded on DPT website - www.deendayalport.gov.in. The provisionally selected candidates will be informed for document verification through ordinary post and E mail. The candidates will be required to produce following documents (in original) along with 1 set of photocopies:
 1. Passport size photo
 2. Aadhar card (with matching name as per ITI / Diploma Engineering / Degree Engineering Certificate)
 3. SSC / Matriculation Mark sheet
 4. School Leaving Certificate
 5. All ITI / Diploma Engineering / Degree Engineering Certificate & Mark sheets
 6. Cast Certificate [SC / ST / OBC (NCL)] (if applicable)
 7. Certificate of Physically Handicapped (if applicable)
 8. Proof for reservation w.r.t. Ex. Serv. (if applicable)
 9. Aadhar linked bank account
- DPT is not liable for postal delay / loss or non – receipt of E mail due to incorrect / false / change of E mail ID (provided in application form).
- If the applicant on the merit list does not remain present and duly prepared on the specific date of reporting for Document verification or the details declared by candidate while applying is found incorrect / false / incomplete, his / her candidature will be rejected and the next applicant (s) on the merit list will be considered. Representation of the applicant in above circumstances will not be entertained.
- The selected candidates shall be required to produce 'Medical Fitness Certificate' issued by Chief Medical Officer, Deendayal Port Trust, Gopalpuri Hospital, Gandhidham (Kutch), Gujarat – 370 240 before starting the apprenticeship training.

Reservation for apprenticeship training slots:

- The reservation in respect of the SC / ST / OBC (NCL) / PH / Ex.Serv. will be as per the norms of the Apprentices Act, 1961 & amendments published time to time and DPT. Valid Certificate will be verified w. r. t. claim for the reservation [SC / ST / OBC (NCL) / P.H. / Ex.Serv.] at the time of document verification.
- Reservation for Ex-Servicemen, their children and children of Armed Forces Personnel is considered as per details mentioned below:

- (i) Children of deceased / disabled ex-servicemen including those killed / disabled during peace time,
 - (ii) Children of ex-servicemen,
 - (iii) Children of serving Jawans,
 - (iv) Children of serving Officers,
 - (v) Ex-Servicemen.
- Provided that when the prescribed number of persons belonging either to the Scheduled Castes or to the Scheduled Tribes are not available, the training places so reserved for them may be filled by persons belonging to the Scheduled Tribes or as the case may be, to the Scheduled Caste and if the prescribed training places can not be filled even in the above given manner, then the training places so lying unfilled may be filled by persons not belonging to the Scheduled Castes or the Scheduled Tribes.
 - If the reserved training places can not be filled from the Other Backward Classes, then the training places so lying unfilled may be filled by persons not belonging to the Other Backward Classes.

Leave:

There shall be two kinds of leave admissible to apprentices:

1. Casual Leave: 12 days in a year.
2. Medical Leave: 15 days in a year.

Discipline and termination of apprenticeship:

The apprentice must observe all the conduct rules applicable to workmen in the DPT. Any disagreement or dispute between DPT and apprentice arising out of the contract of apprenticeship shall be referred to the RDAT for a decision.

Daily Diary / Note-books / Records:

Each apprentice will be required to purchase and maintain work diary, note books, apron etc. at his / her own cost as directed by concerned authorities.

Application procedure:

The notification w. r. t. engagement of apprenticeship in Deendayal Port Trust has been hosted on the www.deendayalport.gov.in.

(A) For ITI Trade apprenticeship (Sr. no. 1 – 9):

- Step 1: Interested & eligible candidates are first required to register through <http://apprenticeship.gov.in> > 'Apprentices' > 'Candidate Registration' and get 'Apprenticeship Registration no.' (of 10 digits) by submitting following details (online):
- Personal details
 - Contact details
 - Qualification details (with attachment of scanned copy of Certificate)
 - Technical Qualification details
 - Trade preference
 - Passport size photograph & Proof of Date of Birth

The application will not be entertained without above mentioned registration.

In past, it has been noticed that Apprenticeship contract registration has failed due to mismatching of 'Name' in Aadhar card & ITI Qualification Degree Certificate. Thus, candidates are requested to produce matching details as per the Qualifying certificate.

- Step 2: Fill the 'Application Form' online available in 'Recruitment' section of DPT website – www.deendayalport.gov.in and click on 'Submit' button. All the data blanks in 'Application Form' are to be filled mandatorily. A flash message acknowledging the successful submission of application will be displayed.

Last date of Application is 26.11.2018.

Candidates are requested to complete the application procedure well in advance to avoid the ending days' rush on website.

(B) For Diploma & Degree Engineering apprenticeship (Sr. no. 10 – 17):

- Step 1: Interested & eligible candidates of Diploma & Degree Engineering disciplines are first required to register on <http://mhrdnats.gov.in> > 'Enroll' & get 'Enrollment number' (of 16 digits) by submitting necessary details (online).

The application will not be entertained without above mentioned Enrollment.


- Step 2: Fill the 'Application Form' online available in 'Recruitment' section of DPT website – www.deendayalport.gov.in and click on 'Submit' button. All the data blanks in 'Application Form' are to be filled mandatorily. A flash message acknowledging the successful submission of application will be displayed.

Last date of Application is 26.11.2018.

Candidates are requested to complete the application procedure well in advance to avoid the ending days' rush on website.

Note:

1. Candidates with qualification acquired through Distance Learning mode / Part time mode / Correspondence mode shall not be considered.
2. Any canvassing directly / indirectly by the applicant may disqualify his / her candidature.
3. The candidature of applicant would be provisional and subject to subsequent verification of certificates / testimonials. In case it is detected at any stage of engagement or thereafter, that a candidate does not fulfill the eligibility norms and / or that he / she has furnished any incorrect / doctored / false, information / certificate / documents or has suppressed any material fact (s), his / her candidature will stand cancelled. If any of these shortcomings is / are detected even after engagement, his / her engagement is liable to be terminated.
4. No Travelling, Boarding or lodging expenses are admissible to the candidates for participating in selection process or for joining at place of posting (in case of selection).
5. No. of apprentices required and duration of apprenticeship training may vary subject to any amendments prescribed by Deendayal Port Trust or RDAT / BOAT.
6. Deendayal Port Trust reserves right to accept or reject any application without showing any cause / reason what so ever. In a particular trade, if suitable candidates are not available, those posts may be transferred to other trades / disciplines at the sole discretion of Deendayal Port Trust.
7. The selected candidates will be governed by the terms and conditions as per Apprenticeship Act of 1961 and further amendments made therein.
8. DPT shall have no obligation to offer employment to Apprentices during and / or after the completion of the apprenticeship period nor can the apprentice claim right for employment on the grounds of completion of apprenticeship.
9. The decision of Management will be final and binding on all candidates on all matters relating to eligibility, acceptance, or rejection of the applications, reservation, mode of selection, cancellation of the selection process either in part or full etc. No correspondence will be entertained in this regard.
