ADVERTISEMENT

Online applications are invited from the Citizen of India for filling up of 33(thirty three)posts of Field Investigator, Group 'B' Non-Gazatted , under the Department of Economics. & Statistics, Govt. of Arunachal Pradesh in the Pay Band of **Rs. 9,300-34,800/- + GPRs. 4,200/- (Pre revised) plus** other allowances as admissible to Arunachal Pradesh Govt. employees from time to time. Out of 33 Posts, 26 posts are reserved for APST candidates including 1 post for PwD (one arm, partiality deaf, partiality (blind) and 7 posts are unreserved. The vacancy position is subject to variation.

1. AGE :- The candidates must have attained 18 years of age and should not be more than 32 years of age as on **08-03-2019**. However the upper age limit is relaxable in accordance with the instructions issued by the Govt. of Arunachal Pradesh from time to time.

2. EDUCATIONAL QUALIFICATION:- Candidates applying for the post must be a graduate in Arts, Science, Commerce with Statistics/Mathematics/Commerce/ Economics as one of the subjects from a recognized University/ Board, that is the candidates having Bachelor's Degree either in

- i. Bachelor of Commerce (B.Com.)
- ii. Bachelor of Arts (B.A.) Honours in Economics/Pass course with Economics as an optional subject for six semesters in Semester system or for three years in Annual system)
- iii. Bachelor of Science (B.Sc.)(Honours in Mathematics/Pass course with Mathematics as an optional subject for six semesters in Semester system or for three years in Annual system)
- iv. Bachelor of (B.Sc.) (Honours in Statistics/Pass course with Statistics as an optional subject for six semesters in semester system or for three years in Annual system)

However, students who have already appeared in final examination of the qualifying degree course and awaiting result shall also be eligible to apply. Such candidates who are declared to have qualified by the Commission in the written competitive examination will have to produce original certificate/Mark-sheets of passing their degree examination issued by the Assistant Registrar/Registrar/Controller of examination/ Vice- Chancellor of the concerned University will only be accepted by the Commission on or before the date of Interview/Viva-Voce. Without the original certificate/Mark sheet they shall not be allowed to appear in the Viva-voce.

3. METHOD OF SELECTION:- The eligible candidate will have to appear in written examination in the following subjects followed by Viva-voce/Interview to be conducted by the Arunachal Pradesh Public Service commission at Itanagar on the basis of which selection will be finalized.

i)	(a) General English	Maximum Marks	100
	(b) General Knowledge	Maximum Marks	100
ii)	One optional paper (Statistics/ Mathematics/Commerce/Economics)	Maximum Marks	100
iii)	<u>Viva-voce test</u>	<u>Maximum Marks</u>	<u>40</u>

The candidate who secure a minimum of 33% or more marks in each written examination papers and has secured 45% of marks out of aggregate total marks in the written examination paper shall be eligible for Interview/Viva-voce test and on the basis of 1:3 ratio norm.

Note: The Commission will adopt Recruitment Test (objective type) before the written examination if it is deemed necessary to do so.

4. FEE:- Candidates are required to pay fee of ₹.100/-(Rupees hundred)only for APST candidates and Rs. 150/-(Rupees one hundred fifty) only for others through online mode only.

5. HOW TO APPLY:- Candidates are required to apply online only through **Website www.appsconline.in** . Brief instruction for filling up of online application is available on the above mentioned Website. .

Syllabus of Optional Subject (Statistics/Mathematics/Commerce/Economics) can be downloaded from the above mentioned website.

6. Scanned copies of following documents and information are to be attached/uploaded.

- (i) Scanned signature of the candidate on white paper with black ink pen (size 20 kb to 60 kb).
- (ii) Recent pass-port size photo (size 40 kb to 100 kb)


7. The candidates declared to have qualified in written examination will have to submit the following documents/Information to the Commission before the interview date.

- (i) Class X Certificate issued by Board/University. Age proof will be based on this only.
- (ii) C lass XII/Diploma Certificate with Mark-sheet.
- (iii) Degree certificate with mark-sheet issued by the Assistant Registrar/Registrar/Controller of Examination/ Vice –Chancellor of the concerned University to ascertain educational Qualification.
- (iv) APST certificate for APST Candidate and PRC/EPIC/Aadhar Card etc. for others.
- (v) Any other documents as may be relevant.
- (vi) Intimation letter to HoD for those who are in regular Govt. service/NOC.

Qualified candidates will have to produce the above mentioned Certificates/Documents and Mark-sheets in original at the time of interview/viva-voce.

8. The decision of the Commission as to the eligibility or otherwise of candidate for admission to written examination or selection will be final and no correspondence or personal enquiry will be entertained.
