The above vacancies are provisional and are subject to change. Normal Rules on reservation for OBC/SC/ST/PH/Ex. Servicemen shall be applicable as per instructions of Government of India issued from time to time. 3% (1.5% for Locomotive and 1.5% for Hearing Impairment) for Physically Handicapped persons and 10% vacancies are reserved for Ex-Servicemen, as per rules.

- 2. Scale of Pay: Rs. 7,100-200-10,100/ (IDA).
- **3.** Selection for a particular Secondary Switching Area (SSA) and Service Liability: On Selection / Appointment, candidate has to serve in the SSA / other non-recruiting Units of BSNL, like Southern Telecom. Region (STR), Southern Telecom. Projects (STP), Quality Assurance (QA) and Testing & Development (T&D) etc.,
- 4. Eligibility:
- (a) Indian Nationals are only Eligible to apply.
- (b) Education:
  - 3 Years Engineering Diploma from a recognized Institution / University in any of the following disciplines
    - i. Telecommunications Engineering
    - ii. Electronics Engineering
    - iii. Electrical Engineering
    - iv. Radio Engineering
    - v. Computer Engineering
    - vi. Instruments Technology
    - vii. Information Technology or

M.Sc (Electronics).

- (c.) Age: Applicant should be between 18 and 27 years, as on the closing date for submission of applications.
  - i. However, the upper age limit is relaxable by 3 years for OBC candidates and by 5 years for SC/ST candidates.
  - ii. For PH candidates, the age is relaxable by 10 years for OC candidates, 13 years for OBC, 15 years for SC/ST candidates.
  - iii. In case of BSNL Employees, age is relaxed upto 40 years for OC candidates, upto 43 years for OBC and upto 45 years for SC/ST candidates.
  - iv. Ex. Servicemen are eligible for relaxation in age as prescribed by the Central Government.

In respect of Physically Handicapped persons, candidate with following physical disability only will be eligible.

- a) Hearing impairment— (PD) Partially deaf
- b) Locomotive impairment- OL One leg affected, or

BL - Both legs affected but no arms

Attested copy of medical certificate in support of his/her claim should be enclosed along with the application. Minimum degree of disability is 40% in order for a person to be eligible for claiming any concession/benefit.

- **5. Registration in Employment Exchange**: Registration in Employment Exchange is not mandatory. However, it would be preferable if the applicant has registration in the employment exchange of the SSA concerned to which the applicant applies.
- **6. Disqualification :** No person, who has
- (a) entered into or contracted a marriage with a person, having a spouse living or
- (b) who having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for the appointment for the said post.
- **7. Examination Fee :** An Examination Fee of Rs. 500/- is payable in the form of Indian Postal Order or crossed Bank Demand Draft in favor of the Accounts Officer of respective SSAs, where the candidate desires to apply for the vacancies, is shown in Annexure-A. The fee shall not be accepted in any other form. The SC/ST/PH candidates are exempted from paying Examination fee. For PH candidates, this exemption will, however, be available to only those handicapped persons who would otherwise be eligible for appointment to the post on the basis of the standards of medical fitness prescribed for that post and who enclose with the application form, necessary certificate from a Govt. Hospital / Medical Board in support of his claim for being handicapped. The fee once paid neither be refunded under any circumstances nor can not be held in reserve for any other examination / selection.
- **8. Enclosures to Application form :** Attested True Copies of (a) Educational Qualifications (b) Age Proof (SSLC / SSC Certificate showing date of birth) (c.) In respect of PH candidate, Medical Certificate (d) Community Certificate in respect of OBC/SC/ST. OBC candidate should produce community certificate as per the proformae for the appointment of OBC in Central Government Service (with creamy layer clause) (e) Attested copy of Discharge Certificate in case of Ex. Servicemen. (f) No objection Certificate from the present employer. (g) Admit Card (Original / Duplicate) duly pasted the recent passport size photograph and attested by the Gazetted Officer (as per Annexure-C) (h) Two self addressed stamped envelopes of 27x12 cms. (i) DD for Rs. 500/ (wherever applicable). (j) Copy of employment exchange registration card, if any.

All enclosures are annexed to the application properly. No column in the application should be left unfilled. The candidate shall affix their signature on all true copies / Xerox copies of certificates apart from attestation by a gazetted officer.

**9.** Already Employed in Govt. Service: (a) BSNL employees are to be submitted their applications through proper channel only. (b) candidates working in Government Service Central / State / Public Sector undertakings should send their application through the Head of their Office / Department so as to reach the concerned office on the due date. Application received after the due date from such offices will summarily be rejected.

- 10. Candidates are advised to send application to **ONE SSA** only and they will be considered for vacancies of that SSA only and they will have to write the examination in the respective Examination centre of the SSA where they have applied. No change of examination centre will be entertained.
- 11. BSNL Reserves the right to amend any clause in this notification in future according to the rules and regulations prevailing at that time.
- 12. Application Form: The specimen of the application form is included in this advertisement (Annexure-B). Neatly typed (only on one side of paper) in A4 size (30Cms x 20Cms) may be used for making application. Application without the signature of the candidate will be rejected outright. The envelope containing the application form should be superscribed as "Application for the post of Telecom. Technical Assistant under Direct Recruitment-2008" in bold letters on top of the envelope. The photo copy of the format given in the advertisement must not be used for applying and in case a candidate submits such an application, the same will not be entertained and no correspondence in this regard will be entertained. The applications complete in all respect along with the examination fee and other enclosures should be sent by Regd. Post / Speed Post / by Hand to the SSA concerned.
- 13. Last Date: Applications should be sent to the concerned respective addresses as shown in Annexure-A, so as to reach them on or before 15.11.2008, by 5 pm. Applications received without the required examination fee, attested copies of certificates, the applications received after the due date and incomplete applications will summarily be rejected. No further correspondence will be entertained in this regard.
- **14. Training and Bond:** All candidates provisionally recruited against the vacancies for direct recruitment shall execute a bond in the proforma as prescribed by the Company to serve in BSNL for a period of 2 years from the date of their appointment as Telecom. Technical Assistant. The candidates selected have to undergo a training successfully as per the training plan laid down by BSNL before their appointment as Telecom. Technical Assistant for a period as prescribed by BSNL from time to time.
- 15. Probation: The candidate appointed shall remain on probation for a period of Two years.
- **16. Jurisdiction :** All candidates shall if so required, be liable to serve in the Territorial Army subject to provisions of Section 6A of the Territorial Army Act 1948 (56 of 1948) and the rules made there under.
- 17. Mode of Selection: Through Competitive Examination, followed by a Medical Test. Appointment and posting will be subject to successful completion of Pre-Appointment Training and other related verifications.
