What is the probability that the card drawn is:


- (i) a face card (King, Jack or Queen)


(b) Solve the following equation:

(c) In the given figure, O is the centre of the circle. Tangents at A and B meet at C. If ∠ACO = 30°, find:




- (ii) ∠AOB

 - (i) The amount of VAT received by the State Government on the sale of this machine from the manufacturer and the wholesaler.
 - (ii) The amount that the consumer pays for the machine.

 - (iv) Give a geometrical name for the figure AA' C' B' BC.
 - (v) Identify the line of symmetry of AA' C' B' BC.


(a) Using componendo and dividendo, find the value of x.

- (c) Prove that (cosec A $\sin A$) (sec A $\cos A$) $\sec^2 A = \tan A$.



Question 11.


