- \* In case sufficient number of eligible candidates with above prescribed Qualification for (E2 level) are not found, those having Post Graduate Diploma in relevant Discipline may be considered for the vacancy of Medical Officer (E1A) with the age limit for E1A grade as prescribed above.
- All Medical Degrees should be recognized by Indian Medical council
- All Medical Degrees should be from reputed institutions and recognized universities also.
- Required minimum Post Qualification experience should be in a large Hospital / Organisation of repute.
- The number of vacancies are tentative and may vary on review, in that eventuality the number of vacancies reserved for various categories may also undergo revision.

- Out of the 04 vacancies of BHEL Bhopal 02 are unreserved and 01 is reserved for OBC and 01 for SC. Out of the 11 vacancies of BHEL Haridwar 05 are unreserved, 03 are reserved for OBC, 02 vacancies are reserved for SC and 01 is reserved for ST. Out of the 04 vacancies of BHEL Jhansi 01 is unreserved, 01 is reserved for SC, and 02 are reserved for OBC. 02 vacancies of BHEL Hyderabad are reserved for OBC and 01 vacancy of BHEL Trichy is unreserved. However, reserved category candidates are also eligible to apply against unreserved vacancies without availing age relaxation benefit prescribed for reserved category candidates.
- Reservation for Physically challenged candidates will be one each BHEL Haridwar, Trichy, Hyderabad and Jhansi.
- Reservation for Ex-Servicemen will be as per the rules

### **AGE LIMIT & RELAXATIONS**

- The date for calculating the cutoff for upper age limit will 1<sup>st</sup> December 2007.
- The upper age limit is further relaxable by 3 years for OBC (Non creamy layer) and 5 years for SC/ST candidates.
- The upper age limit is further relaxable by 10 years for Physically Challenged suffering from not less than 40% disability.
- Relaxation for Ex-Servicemen will be as per extant Govt. Rules.
- A relaxation of 05 years in upper age limit is also admissible the candidates who had ordinarily been domiciled in the state of Jammu & Kashmir during the period from 01.01.1980 to 31.12.1989.

# **EMOLUMENTS AND OTHER BENEFITS**

- The Selected candidates will normally be placed at the minimum of the scale. The Scale of pay for E1A Grade is Rs 11,225-450-17,525/- (due for revision w.e.f. 01/01/2007) and for E2 Grade is Rs 13,750-550-18,300/- (due for revision w.e.f. 01/01/2007).
- Besides the Basic pay, Industrial Dearness Allowance and Non-practicing Allowance (25% of the Basic Pay) will also be paid. Other allowances and benefits such as Leave, Leave Encashment, Medical facilities for self and family, LTC/LTA, Provident Fund, Gratuity, Conveyance Reimbursement, Plant Performance Payment, Special Incentive, Uniform, Subsidized canteen facilities, company's accommodation or HRA etc. will be admissible as per the Company rules from time to time.

## **SELECTION PROCESS**

• For the purpose of selection, if the number of eligible applicants for a vacancy is in the ratio of upto 1:10 to the number of vacancies, only personal interview shall be conducted. However, if the number of eligible applicants for a vacancy is in excess of the ratio of 1:10 to the no. of vacancies then BHEL may decide to hold a written test for all eligible candidates followed by the Personal Interview in the ratio of 1:6 to the number of vacancies. No traveling allowance will be given for appearing in the written test. Candidates invited for Personal Interview will be

#### HEALTH

relaxation in Health standards will be allowed.

- Loco motor Disability means minimum of 40 % of physical defect or deformity which causes an interference with the normal functioning of the bones, joints or muscles. Hearing Impairment means loss of sixty decibels or more in the better ear in the conversational range of frequencies. Blindness refers to a condition where a person suffers from blindness or low vision.
- Only such persons would be eligible for reservation who suffer from not less than 40% of relevant disability.
- The Physically Challenged candidates are required to furnish duly stamped Medical Certificate in relation to their disability from Government Hospital or Medical Board attached to Special Employment Exchange for the handicapped.
- Ex-servicemen candidates should enclose their experience certificate showing their period of service reason for leaving etc.
- Candidates should enclose copies of all relevant certificates (including Experience Certificates) alongwith the application form
- The candidates should ensure while applying that they fulfill the eligibility criteria and other requirements and that the particulars furnished by them are correct in all respects. In case it is detected at any stage of recruitment process that the candidate does not fulfill the eligibility criteria and/or does not comply with other requirements and/or he/she has furnished any incorrect/false information or has suppressed any material fact(s), his/her candidature is liable to be rejected. If any of the above shortcomings is/are detected, even after appointment, his/her services are liable for suitable actions including termination and prosecution.
