NOTICE FOR ADMISSION OF DIPLOMA HOLDERS IN ENGINEERING/TECHNOLOGY/PHARMACY AND B.Sc. WITH MATHEMATICS TO THE 2<sup>ND</sup> YEAR (3<sup>rd</sup> SEMESTER LEVEL) OF 4-YEAR UNDERGRADUATE DEGREE COURSES IN ENGINEERING/TECHNOLOGY & PHARMACY IN WEST BENGAL.

This is to notify that Admission through Lateral Entry to the 2<sup>nd</sup> year (3<sup>rd</sup> semester level) of the undergraduate degree courses (except in Architecture) offered by Government/Private Engineering, Technology and Pharmacy Colleges/ Universities of the State of West Bengal during the academic session 2010-11 is open to candidates who either (i) have passed diploma course in Engineering/Technology/Pharmacy or have passed Degree in Science (B.Sc.) with Mathematics as a subject OR (ii) have passed the previous semesters and due to appear in the final examination – 2010 of the Diploma Courses in Engineering / Technology / Pharmacy or due to appear in the final examination of Degree in Science (B.Sc.) with Mathematics from any recognized Institute/University of the country. Any diploma holder with 60% marks from AICTE approved Institution OR Degree in Science (B.Sc.) from UGC approved University with Mathematics (not applicable for Pharmacy) scoring at least 60% marks in the relevant disciplines will be eligible for admission to degree courses based on the merit position in the JELET-2010 conducted by the "West Bengal Joint Entrance Examinations Board" to be held on Sunday, the 13<sup>th</sup> May, 2010.

The said examination of two hours duration will be conducted with M.C.Q. type of questions. Candidates will be required to answer 100 (hundred) questions each carrying 1 (one) mark. There will be negative mark for wrong answer.

Centres of examination will be selected based on the number of candidates appearing from that area.

**SEATS AVAILABLE**: 10% of the approved intake in 1<sup>ST</sup> Year Level in any Branch of Engineering/Technology/Pharmacy tentatively. However, seats may increase based on drop-out vacancy in 1<sup>st</sup> year level.

**AGE LIMIT:** There is no age restriction for diploma holders of Engineering/Technology /Pharmacy. For B.Sc. candidates upper age limit is 27 years as on 31.12.2010.

**RESERVATION POLICY:** For Government and Government aided Engineering & Technology Colleges, reservation policy of the State Government shall be followed. For University/University Departments: Seat Reservation rule of the concerned University shall be followed.

**APPLICATION**: Candidates intending to appear in the JELET-2010 shall have to apply in a prescribed FORM which will be available from 12.04.2010 to 10.05.2010 both days inclusive from the following Branches of AXIS BANK: In Kolkata & Howrah – Behala, Golpark, Dunlop, CIT Road, Salt Lake Sector I and Panchanantala (Howrah) and Outside Kolkata – Agartala (Tripura)-Banik Tower, Asansol, Barasat, Raigung, Burdwan (G.T. Road), Berhampore, Chinsurah, Coochbehar, Darjeeling, Jalpaiguri, Krishnagar, Malda, Midnapore, Purulia, Siliguri, Suri and Haldia on all working days (except Holidays and Sundays) on payment of Rs. 350.00 (Rupees three hundred fifty) only in CASH. Application Form once sold cannot be returned or replaced.
