<u>General guidelines in filling up the CSSS – 2014 application form</u>

- 1. Candidate must ensure that no item is wrongly filled. The information furnished therein would be used for deciding the eligibility and suitability of the candidates
- 2. Applications not filled correctly, completely are liable to be rejected and the onus of such rejection would be on the candidate himself / herself. The Tamil Nadu Directorate of Higher Education will not entertain any claim after such rejection
- 3. Copies of the certificates should be attached in support of information given in the form wherever necessary
- 4. Fill in the form in English using Capital letters. Forms must be filled in applicant's own handwriting
- 5. Use only BLACK or BLUE ink to fill up the form.
- 6. Square boxes provided in the forms are only for writing the alphabets in capitals or numbers. Only one alphabet or number should be written in one box. Wherever codes are given, fill in the boxes with the appropriate codes
- 7. Overwriting, striking off or erasing in any of the forms may lead to rejection and should be avoided. Any discrepancy in the statement and/or submission of incomplete forms will lead to rejection of application/cancellation of admission
- 8. Keep a photocopy of the filled application for future reference

9. Those students who have passed Class - XII Exam prior to 2014 are not eligible to apply

- 10. Only application forms published in the official websites will be accepted. Forms of previous year or other website printouts will be rejected
- 11. Mere submission of the application form/fulfilling the eligibility criteria will not entitle the applicant for the award of Scholarship. Scholarships will be distributed among various streams and various categories on merit as per criteria advised by the Ministry of HRD, Govt. of India
- 12. Applicant is entitled to receive only one scholarship at a time. If the applicant is in receipt of any scholarship from any other scheme he/she has to refund that scholarship, failing which action will be taken as per rules

13. Application received after due date shall be summarily rejected

14. Applicants are not generally encouraged to have personal communication in this regard. It is advised to send any queries either by post or email (<u>tndceoffice@gmail.com</u>) clearly indicating the issues

Specific guidelines in filling up the CSSS - 2014 application form

Items 1 to 10 are particulars of candidates

- 1. Write the name in CAPITAL LETTERS as it appears in the 10th standard marks card or equivalent. Leave one blank box between adjacent words. Do not use any prefixes like Mr., Mrs., Miss / Ms etc
- 2. The date of birth should be same as mentioned in 10th standard marks card or equivalent certificate.
- 3. Write the complete postal address including PIN CODE to which communications are to be sent, if any.
- 4. Writing the e-mail of applicant and parent/guardian is compulsory. The application form without email id may be considered as incomplete and may lead to rejection. Write the e-mail IDs in CAPITAL letters without blank spaces.
- 5. Mobile numbers of applicant/parent/guardian which is currently in use should be provided in the appropriate box.

Item 11 is the particulars of the present academic status of candidates.

- 6. Do not use short form / abbreviation while filling the college name in item 11(b). Violation of this will lead to rejection of application form
- 7. Use the regular / generic abbreviation in item 11(c) such as B.A / B.Sc / B.Com / B.E / B.Tech / M.B.B.S etc
- 8. If applicable use the regular / generic abbreviation in item 11(d) such as ECE / EIE / CSE etc. Otherwise provide in the expanded form such as Mathematics / Tamil / History etc.

Provide appropriate details in Items 12 and 13 without omissions or corrections.

Item 14 is the Bank particulars of candidates
