## Counselling Schedules for M.Sc. Programmes 2010

The schedule of counselling for the for M.Sc. Applied Chemistry, M.Sc. Applied Mathematics, M.Sc. Applied Physics, M.Sc. Bioinformatics, M.Sc. Bio-Medical Instrumentation, M.Sc. Geo-Informatics, M.Sc. Information Science and M.Sc. Information Technology programmes 2010 of the Institute is as given below. Those candidates who have applied and are eligible for the respective programmes (as given in the PG Information Brochure 2010 (pdf) on the Institute website) should come for counselling at the appropriate Centre / Location (please see below) on the given date.

### Candidates may please note the following:

- Eligible candidates who have applied for the above programmes are advised to reach the concerned Centre (Mesra, Kolkata or Lalpur) by 8.30 am on their respective dates and report at the respective Departments by 9 am
- Candidates who have applied for M.Sc. Information Technology must report at BIT Lalpur
- Candidates who have applied for M.Sc. Bioinformatics should report at that Centre which is their first preference of Place for Study - viz Mesra or BIT Kolkata
- The venue of counselling for each programme will be the Office of the Head of the Department concerned / Office of the Director of the concerned Extension Centre.

At the time of the counselling, candidates will be required to produce the following documents and certificates **in original** and also submit self attested copies of such documents. They should also have two recent color photographs identical to that fixed on the application form.

1. Pass certificate and Marksheet of Class 10
2. Marksheet of Class 12 / Intermediate or equivalent
3. Certificate and Marksheets of Graduation (Qualifying Examination)
4. Marksheets upto pre-final year for candidates who would be completing qualifying examination in 2010. They must also bring the following:
  - a) A certificate in original from the Principal of their Institute stating that the candidate had appeared for examination in all subjects required for obtaining their qualifying degree by 30 June 2010.
  - b) A certificate from the Principal certifying that they have obtained requisite marks, based on latest available grades / marks.
5. Candidates with qualifications acquired through correspondence or distance-learning programmes must carry proof that they have acquired such qualifications as working professionals / while in employment, as well as pass certificate and marksheets of qualifying examination.
6. Caste certificate / special category certificate (if applicable)
7. Two passport size photographs, identical to the photograph affixed in the application form
8. Photo identification: (Driving license, Passport, PAN Card, Voter ID, College ID, Employee Identification Card are acceptable)

**Provisionally selected candidates will be required to submit all the above Documents / Certificates (except photo ID) in original at the time of admission.**

**Provisionally selected candidates who have appeared for final examinations in 2010 will be required to sign an undertaking at the time of admission on Non-Judicial Stamp Paper to the effect that if they fail to obtain the requisite marks in graduation / postgraduation their admission will be automatically cancelled. The deadline for submission of mark-sheet / degree certificate is 31 October 2010, failing which the provisional admission will be cancelled. ### **Counselling Schedules for M.Sc. Programmes 2010**

Provisional selection lists, along with procedures for admissions, will be notified by 2:00pm on the day after the counselling, only on the Institute website and Notice Boards of the Institute. **No separate intimations will be sent to candidates.** Provisionally selected candidates will be required to take admission by the last date mentioned in the notifications, else their offers will be cancelled and allotted to waitlisted candidates. **Candidates are therefore advised to carry the requisite fees to be deposited if provisionally selected.**

**All fees are payable only by crossed Demand Draft in favour of “Birla Institute of Technology” Payable at Ranchi, in case of Mesra or Lalpur Extension Centre and Payable at Kolkata, in case of Kolkata Extension Centre.** For details of fees payable at the time of admission for various programmes please see PG Information Brochure 2010 (pdf) on website. As mentioned therein, students admitted at Mesra will be required to pay a mess advance at the beginning of each semester, which will be adjusted against their mess charges. For the July 2010 session, this mess advance is Rs. 7,000/-
