Samiti directs the office to scrutinize all pending proposals and put them up before Samiti for its consideration in due course. Samiti also makes it clear and further resolves that the institutes, who failed to submit their proposals for the course started during AY 2010-11, would be required to charge the fees from the students only to the extent that those being charged in Government/ Government aided institutes for the respective streams. Samiti will take a serious note, if the institutes deviate from the aforesaid direction on any count.

Item No. 3: To review the present status of pendency of fee approval proposals received for the courses started during AY 2010-11.

(a) To consider and decide on proposals where there are no discrepancies.

&

Samiti considered the proposals of the following Colleges/ Institutes for finalization of fee structure for the students who joined the courses started during Academic year 2010-11. After deliberations, the Samiti decides to approve the final fee structure of the following Institutes/Colleges for the students who joined the course started during AY 2010-11, with a provision for increase in fees for the subsequent years of the course, subject to limit of 7% of the approved fee for AY 2010-11 as shown in the tabular form. For example, if fee fixed for AY 2010-11 is Rs. 1, 00,000/- then each subsequent year of the course, there shall be addition of Rs. 7,000/- maximum.

Item No 4: To consider and decide on the letter dated 11/11/2010 received from Pradnya Niketan Society, Pune, The Orchid College of Engg. & Tech., Solapur for reconsideration of fee fixation for AY 2008-09, 2009-10 in view of an order passed by Hon'ble High Court of W.P.No. 6169 of 2010.

Heard the Institute.

Notice as per our resolution was given. But none is present on behalf of the students/ parents.

The matter was heard fully and the points are noted. Our Chartered Accountant is asked to look into them & the accounts. The Institute is also asked to produce the zerox copies of original contracts for considering fully the cleaning charges and security charges. On the face the claims thereof are exorbitant. Norms of AICTE regarding the space requirement per student to be submitted (there are 240 student). The order to be dictated thereafter.

Item No 5: To consider and decide on the letter dated 09/12/2010 received from B.Ed. College, Kagal to accept the proposal for fixation of fee structure for A.Y. 2010-11.

It is not possible to entertain the request in the letter dated 19/12/2010 to get time to file the proposal for the course started during the year 2010-11. It is stated that the institute has asked for extension of time by letter dated 25/06/2010. Infact the time was generally extended & notified till the end of September, 2010. Even then the proposal was not submitted. Hence the application is rejected. Institute may file the proposal for next year i.e. 2011-12.

Item No 6: To consider and decide the review applications received from Colleges against the fee structures declared by the Samiti for A.Y. 2010-11.

1. (B-HMCT) A.J.M.V.P.S. Institute of Hotel Management & Catering Technology College Ahmednagar-414001:

Heard the Institute.

The Institute has given notice as per our resolution. But none is present on behalf of the students/ parents.

It is pointed out that there was an error in mentioning the proposed fee. The Interim fee was mentioned as proposed fee. The fee finally declared was Rs. 35,940/-. The point raised is that certain actual expenditure for the year 2009-10 was not considered. There is some substance in this. If the error is corrected then the fee would come to above Rs. 41300/-. The Institute has also given letter dated 23/12/10 stating that their fee may be finalized at Rs. 41,300/-. We finalize the same. Office to declare it.

2. (D1147) Rambhauji Lingade Polytechnic College, Buldhana-443001:

The party is absent at the time of hearing. Matter to be taken up in the next meeting. Fresh notice to be given to the students/parents of next date..

3. (MB3116) Fr. C. Rodrigues Inst. Of Management Studies, Navi Mumbai, Vashi- 400703:

Heard the Institute.

The Institute has given notice as per our resolution . One student was present. He is praying for time to file a reply. Hence, matter to be taken up in the next meeting.

4. (EN 3197) Fr. Conceicao Rodrigues College Of Engineering,Vashi, Navi Mumbai-400703:

Heard the Institute.

The Institute has given notice as per our resolution been given. But none is present on behalf of the students/ parents.

The points raised are –

- 1) Ten percent Salary was not correctly disallowed.
- 2) Depreciation has not been considered properly.
- 3) 6th pay commission component of Rs. 5,930/- was not consider and wrongly for accreditation additional fee was allowed. There is some substance in this. If recalculated the fee comes to about Rs. 66,000/-, including 6th pay arrears of Rs. 5,930/-. The Institute has also given letter dated 23/12/2010 stating that such fee may be declare. We accept this. Office to declare it.

5. (B.Ed.) Akbar Peerbhoy College Of Education,Vashi,Navi Mumbai-400703:

Heard the Institute.

The Institute has given notice as per our resolution. But none is present on behalf of the students/ parents.

This is in respect of fee for the year 2010-11. The fee finalized was Rs.55000/-. The Interim fee declare was Rs. 61,200/-. The Institute has collected it from the students.

The point raised is regarding not allowing salary expenditure fully. There is some substance in it. If recalculated fee would be around of Rs. 60,000/-. The Institute has given letter dated 23/12/10 that their fee may be finalized at Rs. 60,000/- & the excess amount of Rs. 1200/- collected would be refunded to the students. We accept this. We finalize the fee of Rs. 60,000/-

6. (EN 3185) Vivekanand Education Soc. Institute Of Technology, Mumbai-400071:

Heard the Institute.

The Institute has given notice as per our resolution. But none is present on behalf of the students/ parents.


