## **Detailed Analysis**

**Objective type questions:** This part of the paper was Jumbled in nature. There were 10 questions on two sets of Reading Comprehension passages, 37 questions on English Usage, 8 questions on Quantitative Ability, 15 questions on Logical Reasoning, 75 on General and Legal Awareness and 10 questions were on first type of Legal Reasoning (Factual Situation and Principle) and 5 questions were on second type Legal Reasoning. This year there were no question on Data Interpretation.

There were 2 RC passages, the first was on **Global Warming** while the second passage was on **Poetry**, there were 5 questions were asked on both of this passages. The breakup **Reading Comprehension** questions will be clear to you by the following table
