- 2. The applicants should bring his/her Bio-Data (format enclosed Annexure-I & II) alongwith copy of Marks Sheets, Degrees and Certificates of experience, and other testimonials, and one recent passport size photograph.
- 3. During the validity of the Contract of engagement, while on duty, engaged person shall (i) observe the punctuality & discipline (ii) attend Office on all working days, and, if necessary on holidays. If required, he/she will have to work even beyond normal office hours.
