The candidates intending to join Medical/Engineering degree programmes are required to have obtained 'Advanced' level passes in Physics, Chemistry, Biology/Mathematics and English at AS Level.

# **Examinations considered as equivalent to Class XII**

- The final examination of the 10+2 system, conducted by a Central or State Board recognized by the Association of Indian Universities (www.aiuweb.org).
- Intermediate or two-year Pre-University examination conducted by a Board or University recognized by the Association of Indian Universities.
- Final examination of the two-year course of the Joint Services Wing of the National Defence Academy.
- Senior Secondary School Examination conducted by the National Institute of Open Schooling with a minimum
  of five subjects.
- Any Public School, Board or University examination in India or in a foreign country recognized as equivalent to the 10+2 system by the Association of Indian Universities (AIU).
- H.S.C. vocational examination.
- A Diploma recognized by All India Council for Technical Education (www.aicte-india.org) or a State Board of Technical Education of at least 3 year duration.
- General Certificate Education (GCE) examination (London, Cambridge or Sri Lanka) at the Advanced (A) level.
- High School Certificate Examination of the Cambridge University or International Baccalaureate Diploma of the International Baccalaureate Office, Geneva.

Candidates who have completed Class XII (or equivalent) examination outside India or from a Board not specified above should produce a certificate from the Association of Indian Universities to the effect that the examination qualified by the candidates is equivalent to the Class XII examination.

In case the Class XII examination is not a public examination, the candidate must have passed at least one public (Board or Pre-University) examination earlier.



# Policy for giving NOC and equivalence to institution affiliated to CBSE, ICSE, Cambridge, IB & other boards-fc secondary & higher secondary schools

Guiarat Government

#### Preface:

As per (1) above & Board's bylaws for secondary & higher secondary schools, the scho seeking affiliation to CBSE. ICSE & other Indian govt, boards were issued NOC. As of now, the has been no provision for issuing NOC to boards other than the state govt. & Indian go boards. Due to this issuing of NOC to schools seeking affiliation to such boards gets delay inordinately. In the Global Investors Summit 2009, the state govt, has identified the educati sector also as a separate investment sector. Keeping this in mind, healthy competition welcomed to improve the quality of education. For this purpose, the govt, was considering comprehensive policy to expedite the process of quickly issuing an NOC to the scho 3. The board will have to demand necessary information within 10 working days from seeking affiliation with the Indian govt. as well as international aforesaid boards (IB, Gene or Cambridge University, London).

#### Resolution:

It is resolved, following a careful contemplation, to issue an NOC to schools seeking affiliati with CBSE & ICSE boards of Indian govt. as well as international boards (IB, Geneva Cambridge University, London) under the following conditions:

1. The school(s) seeking the NOC shall submit an application to Sachyshri, Guja secondary & higher secondary board-Gandhinagar with the information as p

annexture-1. The application-fees will be finalized by Gujarat secondary & higher secondary board-Gandhinagar, which will be uniform for all the boards as mentioned in the preface. The school(s) will have to submit along with the application an undertaking showing their willingness to follow all the rules & regulation as laid down by the concerned board.

- 2. The application would be verified with Gujarat secondary & higher secondary board-Gandhinagar and a proposal would then have to be submitted to the govt. with the information as shown in the annexture-2.; and if need be, the information related to following matters would have to be sought from the DEO (District Educational Officer):
  - BU permission, local taxes etc
  - If the proposed site for school-building is appropriate form health & hygiene point of view and give reasons if not.
  - If the school-building is appropriate from the safety & security viewpoint (e.g. safety measures for the hazards/calamity like fire, earthquake etc. have been effected or no, and give reasons if not)
  - If the commencement of school at the proposed site in any way comes in to conflict with the local laws or no and supply reasons if so.
- the receipt of the application from the institute from the concerned DEO only if inevitable and the concerned DEO will have to send to the Board all the required information/clear verdict within 10 working days following the site-inspection, failing which the investigation will have to be carried out by another officer and the proposal along with clear verdict/opinion be sent to the Education Department within 30 working days without fail.
- 4. Once application having been received, all the formalities including the aforesaid (3) for issuing the NOC will have to be completed within 45 working days. This limit can be extended up to 60 days in special cases. The NOC is to be issued with permission from Principal Secretary (education).

- 5. The NOC given to the applicant institute will be valid for 6 months from the date of issuing. The onus of acquiring the affiliation with the concerned board rests with the applicant school, failing which the applicant school will have to submit application with valid reason to the state govt, for the extension of the NOC validity for another six months. In absence of receipt of any such application made to the govt; the NOC would automatically be deemed null & void.
- Within the time-frame as mentioned in (5), the applicant school will have to submit an attested copy of the affiliation with the concerned board to the state govt. & Gujarat secondary & higher secondary board-Gandhinagar.
- 7. The state govt. shall in no way be responsible for any fiscal, administrative or any other liability for the applicant school receiving the NOC.
- 8. Those institutes to have received the NOC and acquired affiliation with the other boards will have to submit an attested copy thereof to Gujarat secondary & higher secondary board-Gandhinagar and get the registration done. The responsibility of issuing equivalence certificate to those students of such schools wanting to migrate to the state board will be of Gujarat secondary & higher secondary board-Gandhinagar. Gujarat secondary & higher secondary board-Gandhinagar will & cannot be held responsible for issuing of such an equivalence certificate unless the institute has registered itself with Guiarat secondary & higher secondary board-Gandhinagar.
- 9. Investigation/verification will and could be carried out by the concerned DEO for the grievances/complaints received concerning (1), (2), (3) & (4) in point no. 2 and the report for the same will have to be submitted for necessary actions-to-be-taken to concerned central/international board through Gujarat secondary & higher secondary board-Gandhinagar.
- 10. A certain norms/rules & regulation have been framed by the Association of Indian Universities, New Delhi giving accreditation to the different boards of Indian govt. as well as other boards as even giving equivalence to the results of std. XII. All these norms/rules & regulations will have to be followed by all the universities in Gujarat in order to give admission in higher studies/streams courses, and the universities have to notify the same to that effect to all the colleges affiliated under them respectively. In this regard, acknowledgement of acceptance of all the instructions of this resolution will have to be intimated to the Education Department within maximum 6 months.

Circular No. 230 of 2008-2009

Subject: Information regarding Eligibility conditions and verification of Eligibility Application Forms in respect of various courses of the University.

Principals of affiliated colleges, Directors of recognised institutions and Heads of University Departments shall take the responsibility of doing all the work related to eligibility of students admitted by them to various courses of the University in their respective colleges/institutions/ University Departments.

Eligibility certificate is the first document which enables the students to get admission to the chosen course in the College & Institutes under University Jurisdiction. In the interests of the students as well as in the academic interests of the University, it is necessary that the process of issuing eligibility certificate should be completed expeditiously. If such process is delayed or remains faulty due to any reason, students and alongwith them all other concerned have to suffer. Money spent by the students and their valuable years are wasted.

To avoid such eventuality or at least to minimise the same, it is necessary that this process should be completed very carefully, cautiously and with speed. The Heads of University departments/ the Principals of colleges as well as Directors of recognised Institutes are requested to note carefully the following instructions for this purpose:

- The Principal of the College or Director of the Institute should check that the applicant satisfies all the conditions of admission to the concerned course before admitting such an applicant i.e. admissions are to be made according to the rules.
- The Principal/Director/Head, University Department shall ensure that the student has submitted copies of the required Certificates. The Principal/Director/Head shall verify the true copies with the originals and endorse accordingly.
- The originals should be retained by the College/Institute/University Department and should be made available to the University officials at the time of verification of eligibility.
- The student is responsible for any discrepancy, error, wrong or incomplete information in the form. The authority granting admission shall ensure that the student has filled application completely and without any mistake.
- Eligibility shall be decided strictly as per the provision of Ordiance No. 56 to 64 and 0.115 & 0.116.
- The Principal of the affiliated college and Director of the Recognised Institute/Head, University Department shall note the contents of University Circulars issued in this regard from time to time.

- □.(c) Students joining any course on the basis of having passed qualifying examination from Pune University will also be required to fillup the eligibility forms.
- □.(d) The College/Institute/Department shall maintain the record of eligibility cases for 3 years from the date of admission.
- 15. Change in Name: It shall be ensured that name of the student in the application form for eligibility and statement of marks, passing certificate, Degree Certificate of the qualifying examination or in any other document enclosed therewith is the same. If in any case there is a difference in the name i.e. in the case of a girl-student if name after marriage is different, proof for change in name, such as copy of Government Gazette, Marriage Registration Certificate, Affidavit should be enclosed along with the application form. Eligibility Certificate shall not be issued in the absence of such documentary proof.
- 16. Admissions as per provisions of Ordinance No. 59: The Principal/Head/Director shall ensure that in case of a student to whom admission is granted in anticipation of declaration of his result, as per provisions of Ordinance No. 59, the necessary certificates are received within two months from the date of admissions, failing which Principal/Head/Director shall cancel the admission of such student under intimation to the University and the student concerned.
- 17. Recognised Degrees / Diplomas: Students passing degrees/diplomas from the Universities/Boards/other Examining Bodies which are recognised by Association of Indian Universities, New Delhi are only eligible for admission in this University on a reciprocal basis provided that the entrance qualifications, duration of the course and the general standard of attainment is similar to those prescribed by this University (lists of such Universities, HSC Boards and Examining Bodies are enclosed). (Annexure 'B')
  - \* However in case of degree awarded by open universities the condition regarding andduration of course may be relaxed, provided that the general standards of attainment are similar to those prescribed by the Recognising University.
- 18. Admissions of External Students as regular students: The candidate registered as external student of the University shall be eligible for admission as a regular student in the next higher class of the same course and vice versa.
- As per U.G.C. directives a Graduate means a Bachelor Degree holder of three years duration course of a Statutory Indian University.
- Admission to courses after Graduation: For the purpose of admission to second
  Graduation course or Post Graduation course the candidate should have passed Graduate
  course of three years duration of this University or any other statutory Indian University
  or equivalent examination.
- Eligibility of MCVC (minimum competency vocational course) is equivalent to XII<sup>84</sup> of Maharastra State Board of higher Education.
- The students who are passing "A Level Examination University of Cambridge is equivalent to XII std of Maharastra State Board of secondary and Higher secondary (Government of Maharastra)
