GENERAL INFORMATION

The admission process in Shri Ram College of Commerce usually begins in the month of June every year when the University of Delhi opens admissions for different courses in the University of Delhi and its constituent/affiliated colleges. The University of Delhi releases a detailed Admission Schedule/Notification usually by the end of May every year. Being a constituent College of the University of Delhi the admission schedule/notification released by the University of Delhi is followed by the SRCC for admissions to its undergraduate courses. The details about the college, courses, admission critieria for different courses, etc. are published by the college in the Prospectus for admission. The prospectus is usually available for sale from the fourth week of May every year.

For the year 2012 the University of Delhi has made significant changes in the admission process. The candidates can register either online at <u>www.du.ac.in</u> or offline by filling OMR Forms available from designated post offices and Admission Information Centers in Delhi.

ADMISSION ON MERIT BASIS

As per notification of the University of Delhi for admissions to undergraduate courses in the year 2012 the candidates desirous for admission in colleges of the University of Delhi are required to register their name for admission by filling OMR Registration Form. The form can be obtained from and deposited at designated Admission Information Centers or Post Offices in Delhi. The candidates are not supposed to fill any form with the colleges of their choice.

Under this system the University of Delhi after completion of registration process will send the details of candidates to different colleges as per choice of candidates for their preferred Colleges and Courses. The SRCC will draw out the list of eligible candidates and cut-off percentage on the basis of available seats and order of merit of candidates. Only those candidates will be considered for admission who are registered with the University of Delhi for admission as per prescribed procedure.

Candidates whose name appears in the list of eligible candidates or whose percentage matches with the cut-off percentage declared by the SRCC will be required to get his/her admission confirmed by completing required admission formalities with the SRCC within the stipulated dates, failure of which he/she will lose the opportunity of his/her admission. In case seats remain unfilled the SRCC will release subsequent list and/or cut-off percentage for admission as per pre-notified dates. Eligible candidates must confirm their admission by completing admission formalities with the college in such cases.

Candidates are advised to follow the Admission Notification and Admission Schedule for the concerned academic year. Candidates are also advised to ensure their eligibility for admission under the concerned undergraduate course as per Admission Category and Criteria declared by the SRCC.

ADMISSIONS UNDER RESERVED CATEGORIES

The candidates belonging to different reserved and other special categories, viz. SC and ST, Persons with Disability (PwD), J & K Migrants, Children of War Widows, Foreign Students, etc. who wish to be considered under their respective category should register themselves with the University of Delhi as per Admission Schedule/Notification of the University. The University of Delhi releases Admission Slips to the eligible candidates bearing their name and college where they are recommended admission. Students who are issued **Admission Slips** for SRCC should contact the Admission Committee for admission with Admission Slip in person for completing admission formalities and deposit of fee as per instructions and within notified dates and timing mentioned on the slip.

ADMISSION UNDER RESERVED CATEGORY OF OBC

The admission procedure for candidates belonging to OBC (Non Creamy Layer) category is same as meant for admission of candidates under Merit Basis. A separate cut-off will be declared by the College for candidates under the OBC category.

Candidates are, therefore, advised to obtain the OBC Certificate beforehand to avoid any inconvenience at later stage and ensure that:

- a. Certificate is in the name of the candidate
- b. The caste is included in the Central List for OBC
- c. The certificate mentions non-creamy layer status of the candidate
- d. The certificate is obtained from the concerned Competent Authority in a formal manner.

ADMISSION ON SPORTS BASIS

The College has twenty seats for admission on Sports Basis. Candidates who wish to be considered for admission on Sports basis should apply to the College by submitting a prescribed Preliminary Application Form available from the College, in addition to their candidature for admission on merit basis or under any reserved category. The desirous candidates are advised to confirm the available seats under different games before filling the application form for admission on the basis of sports.

Candidates are considered for admission on the basis of their past three years performance/achievements in different sports tournaments/competitions and ground trials. A weightage of 50% is given to the certificates/achievements of the candidate's best performance of the last three years and weightage of 50% is given to field trials.

The aspiring candidates are advised to follow the admission schedule/notification, guidelines and procedure for admission under this category.

Candidates can also download the Preliminary Application Form for admission under Sports Category. The form should be accompanied by relevant certificates and a bank draft of Rs.20/- drawn in favour of "Principal, Shri Ram College of Commerce", payable at Delhi. The application form in any case should reach to the College on or before the last date for submitting the form. Candidates should read the General Instructions carefully before filling Form and applying under Sports Category.

The student who is admitted to B.Com. (Hons.), which is an academic course, should possess theoretical and analytical competence which may not be provided by the study of vocational papers such as, Needle-work & Dress-Making, Cookery, Physical Education, Entrepreneurship, Environmental Studies, Home Science, Music, Fashion Studies, Typing and Shorthand, Computer Studies, Science & similar subjects.

To elucidate, if a candidate in Eligibility Category E has 97% marks, his/her marks are equivalent to 95% marks in Eligibility Category A.

To elucidate, if a candidate in Eligibility Category B has 93% marks, his/her marks are equivalent to 94% marks in Eligibility Category A; and if a candidate in Eligibility Category C has 90% marks, his/her marks are equivalent to 91% in Eligibility Category A.

HOW TO OBTAIN PROSPECTUS

The prospectus for the concerned academic year is available before the start of admission process. The candidates can purchase Prospectus from the College Office on any working day from Monday to Friday between 9.30 a.m. to 1.00 p.m. The Prospectus can also be obtained by post/courier. For this purpose a bank draft for Rs.150/- (Rs.500/- if required abroad) drawn on "Shri Ram College of Commerce", payable at Delhi should be sent at following address. Do mention your name, address, land line and mobile number(s) on the reverse of the bank draft.



- k. Three copies of Caste/Category certificate (if admitted under any reserved category). The candidates belonging to OBC categories should ensure that Certificate is in the name of the candidate, the caste is included in the Central List for OBC and the certificate mentions non-creamy layer status of the candidate.


