**CET-2014 - Revised Schedule for
Document Verification and Option Entry for Online Seat Allotment**

The Government in its letter No. ED 56 TEC 2014 dated 17-05-2014 has directed KEA to take necessary steps to complete the online seat allotment process in compliance with the proceedings of the meeting held on 15-05-2014. Hence the schedule given in the CET-2014 brochure for document verification and Option Entry for Online Seat allotment process stands altered. The eligible candidates have to attend the document verification as per the following revised schedule in any of the nearest Helpline Centre to become eligible for Option Entry. Candidates needs to bring their original documents for verification in any of the KEA's 13 Helpline Centre detailed in KEA Website <http://kea.kar.nic.in> Verification of documents will be done at once for all the disciplines to which the candidate is eligible. If a candidate has got multiple ranks, then he / she can come to the Helpline Centre on the scheduled date as per his / her highest rank in any discipline and need not come again for other ranks in other disciplines.

Schedule for General Merit, all Reserved Categories and all Special Category Candidates

The candidate who becomes eligible after verification will only be considered for entry of options. **The candidate will have the choice to enter all the options in the discipline to which he/she is eligible.** Candidate can enter the options for all the discipline at once. If the candidate is eligible for multiple disciplines i.e., both for Medical / Dental and Engineering or for Medical / Dental / Farm Science courses / B.Pharm, options can be exercised for all the discipline in the same entry form.

NOTE:

- All other guidelines and procedures given in the CET-2014 brochure remain same for all other purposes.
- All the concerned colleges should report to KEA through KEA Web-portal, every evening the details of admission of students selected through KEA and also the students who has not reported details within the stipulated time, so that the non-reported seat will be taken for next round of seat allotment.
- To claim seat under Hyderabad-Karnataka Reservation (Article 371 J), the candidates should produce the relevant certificate issued by the concerned Assistant Commissioner during document verification.
- The candidate should compulsorily bring all necessary original documents (along with one set of attested photocopies) in support of their claim when they come for verification without fail on the notified date. If any candidate fails to produce any of the original documents / certificates / marks card on the day of verification, such candidate's documents will not be verified and they will not complete their registration process and subsequently will not be considered for eligibility to exercise their options.
- If a candidate has not received the original marks card of Qualifying Examination for 2014 from the concerned boards, then the candidate should obtain the signature of the Principal of the institution where he / she has passed 2nd PU / 12th Standard examination on the provisional marks card. Internet downloaded marks cards will not be accepted.

N.B.: No individual intimation will be sent to the eligible rank holders regarding the date and time of Verification process.
