In compliance to Uttarakhand State GO No.1435/XXVIII(1)/2010-150/2005 TC-I dated 21 December, 2010, Uttarakhand Technical University, Dehradun will conduct the competitive Entrance Examination on 12th Feb, 2011 (Saturday) for admission to MD/MS/Diploma courses in Allopathic Medical Colleges of Uttarakhand i.e. Government Medical College, Haldwani and Himalayan Institute of Medical Sciences, Jolly Grant, Dehradun for the year 2011.

(I) For MD/MS/Diploma Courses (Allopathic)

The competitive Entrance Examination shall be open to such candidates who:

- a) Have passed the M.B.B.S. Examination from Uttarakhand viz Government Medical College, Haldwani and Himalayan Institute of Medical Sciences, Jolly Grant, Dehradun and were admitted though competitive examination and not through NRI/Management Quota.
- b) Are domicile of Uttarakhand and have passed M.B.B.S. Examination from Medical Colleges of other States and were admitted through 15% All India Quota (Vide *Supra*).
- c) Are domicile of Uttarakhand and have passed M.B.B.S. Examination from Medical Colleges of other States India and were admitted through Combined Pre Medical Test conducted by the Concern State Government.
- d) Have completed Rotatory Compulsory Internship on or before 31st March 2011.

(II) Details of Seats:-

(i) Himalayan Institute of Medical Sciences, Jolly Grant:-

No. of Seats in different disciplines of Himalayan Institute of Medical Sciences, Jolly Grant, Dehradun may decrease or increase or cancelled for this Exam/ Academic year and *these seats will be filled subject to the decision in writ petition NO. 236(M/S)/2008 (State of Uttarakhand V/s the Himalayan Institute of Medical Sciences & Others) in Hon'ble High Court, Uttarakhand.

Note 1:- In spite of the best efforts of the state government the medical services are not improving due to difficult topography and undulated terrain of the state. Most of the Medical Officers have resigned from these remote hilly areas who were selected for these particular areas

and rest of them did not join the Government Hospital. At present most of these posts are vacant in remote hilly areas. The State Government is bound by Constitution to provided high quality medical facilities to mitigate infant mortality rate and maternal mortality rate. The State Government is trying to strengthen the Medical Facilities in these areas.

In this context the Government has decided that all Government PG seats of Govt. Medical College, Haldwani and those coming in future with post graduate teaching facilities, their seats will be fulfilled by the UPGMEE Students, who will provide five years compulsory service to Uttarakhand state as where & When Government decided to post them.

Hence candidates are required to executive a Bond on a prescribed Performa, as per Government direction, for 5 yeas compulsory service to Uttarakhand state at the time of admission.

Note 2:- Ten percent of total number of seats will be reserved for PMHS (Provincial Medical and Health Services) doctors and these PMHS (Provincial Medical and Health Services) candidates can get admission through UPGMEE-2011 entrance examination.

(III) Examination fee and last date of receipt of completed application form/OMR:-

- 1- Rs. 5000+40=5040/- for General and OBC Category
- 2- Rs. 2500+40=2540/- for ST & SC Candidates
 - **a.** Fee of Rs. 5040/- and Rs. 2540/- as described above will be paid in cash at the time of purchase of brochure/application form at the GPO, Haldwani and GPO, Dehradun.
 - **b.** The Candidates can also download the admit cards from the website of the University, which is valid for appearing in the examination. However the candidates will be given original admit cards at their respective examination centres a day prior to the fix date of examination as well as one hour before on the date of the examination. (Information and Instructions to the candidates and to be retained by the applicant)

1. **GENERAL**

- (i) As per Government of Uttarakhand order, Uttarakhand Technical University, Dehradun, will conduct the Competitive Entrance Examination for selecting candidate for admission to MD/MS/Diploma courses in the Allopathic Medical College of Uttarakhand viz. Government College of Haldwani and Himalayan Institute of Medical Sciences, Jolly Grant, Dehradun, for the Academic year 2011.
- (ii) The eligible candidates who get selected through U.P.G.M.E.E. 2011 will be given admission on available seats in post graduate courses by counseling on merit cum choice basis.
- (iii) A candidate who is already admitted to any post graduate course will not be eligible to appear in the U.P.G.M.E.E.-2011 till he/she completes the course and passes the examination.
- (iv) The Entrance Examination for admission to all courses for 2011 shall be held on 12th February, 2011 (Saturday) at Haldwani & Dehradun at designated centres.

2. POST GRADUATE COURSES

- (i) The M.D./M.S course shall be of 3 years duration.
- (ii) The Diploma course shall be of 2 years duration.

3. ELIGIBILITY CRITERIA

(i) For Allopathic Postgraduate MD/MS/Diploma Courses:

The competitive Entrance Examination shall be open to such candidates, who:

- (a) Have passed the M.B.B.S. examination from Uttarakhand viz. Government College of Haldwani and Himalayan Institute of Medical Sciences, Jolly Grant, Dehradun and were admitted through competitive examination and not through NRI/Management quota.
- (b) Are domicile of Uttarakhand and have passed M.B.B.S. examination from Medical Colleges of other States and were admitted through 15% "All India Quota".
- (c) Have completed/will be completing Rotatory Compulsory Internship by 31st March, 2011.
- (d) Are domicile of Uttarakhand and have passed M.B.B.S. Examination from the other State's Medical Colleges of India and were admitted through Combined Pre Medical Test conducted by the Concern State Government.

- (e) Now there is no age bar for candidates to appear in the examination.(Please refer to our website Letter No. MEMO/UPGMEE/2011for detailed information).
- (f) PMHS (Provincial Medical and Health Services) Uttarakhand service cadre doctors can also participate in entrance examination and upper age limit for these doctors will be 40 years on 31st March 2011.

4. SCOPE OF EXAMINATION, EVALUATION & ELIGIBILITY FOR ADMISSION FOR ALLOPATHIC POST GRADUATE MD/MS/DIPLOMA COURSES

- (i) The Competitive Entrance Examination for M.D., M.S., and DIPLOMA courses shall consist of two written papers as follows:
 - (a) **Paper-I:** shall consist of 150 questions in pre and para-clinical subjects. It shall be of two hours duration and shall carry maximum of 600 marks.
 - **(b) Paper-II:** shall consist of 150 questions in clinical subjects. It shall be of two hours duration and shall carry maximum of 600 marks.
 - (c) The questions shall be of the M.B.B.S. level. The number of questions from different subjects in the two papers shall ordinarily be as follows:

- (ii) All the questions will be **objective type** with multiple (A,B,C,D) choice of which only one will be the most appropriate answer and, therefore, the correct choice. Each answer with correct choice shall be awarded **FOUR marks**. **ZERO** marks shall be given to no answer. **ONE** mark shall be deducted for each **wrong** answer. If more than one choice is indicated against a question it shall be considered as **incorrect** answer and **ONE** mark will be deducted for each such **incorrect** answer also.
- (iii) Answering Method: Read the instruction of OMR Answer sheet carefully.
- (iv) Minimum marks criteria: General Category candidates shall have to secure a minimum of 50% marks and the reserved category candidates a minimum of 40% marks in order to qualify for admission to a Post Graduate Medical course.
- (v) Candidate eligible in the reserved category will be given admission as per rules of State Government.

5. APPLICATION FORM

- (i) Application forms/brochures will be made at GPO, Haldwani and GPO, Dehradun from 25th Jan, 2011 onwards until 6th Feb, 2011 on cash payment of Rs. 5040/- (General and OBC) or Rs. 2540/- (SC/ST).
- (ii) Those candidates, who are using online or downloaded application forms will submit their fee alongwith the completed application forms with a draft of Rs. 5000/- (General and OBC) or Rs. 2500/- (SC/ST) in favour Finance Controller, Uttarakhand Technical University, Dehradun.
- (iii) A candidate seeking admission to the competitive entrance examination is required to send his / her application on the prescribed application format, also downloadable from the website: www.uktech.ac.in., completed in all respect to the office of Registrar, Uttarakhand Technical University, Govt. Girls Polytechnic Campus, Suddowala, Post-Chandanwari, Premnagar, Dehradun-248 007.
- (iv) A candidate should not fill in more than one form for the U.P.G.M.E.E.-2011.
- (v) Before filling up the application form, the candidate must familiarize himself/herself with the information given in this brochure.
- (vi) Every detail must be filled in by the candidate in his / her own handwriting. All answer must be given in words and not by dashes or dots. No column should be left blank. Where a column is not applicable, mention "NA".
- (vii) <u>Incomplete application form and forms without examination fee {As explained in para-(ii), (iii) above} in the form of Demand Draft, shall be rejected.</u>
- (viii) Candidate must affix passport size photographs in the space provided on the application form. The candidates who have completed their internship can get their photographs attested by a gazetted officer. Those who are still pursuing their internship programme shall get their photograph attested by the Dean/Principal of their respective institution along with the certificate mentioning expected date of completion of internship, latest by 31st March 2011.
- (ix) Furnishing of false information or suppression of any information would disqualify the candidate from the competitive entrance examination/admission and cancellation of admission if already admitted. If considered necessary, legal action may also be taken against such candidate.
- (x) Application form of the candidates, who are likely to complete internship on or before 31 March 2011 for MD/MS/Diploma Course has to be countersigned by the Dean/Principal of Medical College from where the candidate has passed the M.B.B.S. examination in the forwarding note column.
- (xi) Candidate employed elsewhere must give a 'no objection certificate' signed by the employer/Director General, Medical, Health and Family Welfare, Uttarakhand for appearing in the entrance examination failing which the application shall be rejected.

6. COMPETITIVE POSTGRADUATE MEDICAL ENTRANCE EXAMINATION, 2011

- (i) The Postgraduate medical entrance examination of 2011 will be held on 12st Feb, 2011 (Saturday) at G.R.D. Institute of Technology, Rajpur Road, Dehradun & Government Medical College, Haldwani (Nainital).
- (ii) Registrar, Uttarakhand Technical University, Dehradun shall not be responsible for non-receipt of admit cards due to any reason. Admit Card will not be sent to ineligible candidates and no correspondence in this regard shall be entertained nor shall their fees be refunded.

- (iii)However, if due to any reason the candidate fails to receive the Admit Card. The eligible candidates can get a provisional Admit Card issued from the University website: www.uktech.ac.in. However the candidates will be given original admit cards at their respective examination centers one day before(11th February 2011) and one hour before, on the date of the examination(12th February 2011) scheduled. Such candidates must bring one attested copy of the same photograph, which he has affixed with the application form. For information regarding examination centre or any other Quarry the candidate can contact Registrar (U.P.G.M.E.E.-2011) on Telephone no. 0135-2770126, 2770127.
- (iv)Entry to the Examination hall will be restricted to candidates producing the admit card, issued by the Registrar (U.P.G.M.E.E.-2011), Uttarakhand Technical University, Dehradun or Competent Authority of examination Centre.
- (v) **Paper-I** will commence at 10:00am on 12th Feb, 2011(Saturday) and will be of two (02) hours duration. Similarly **Paper-II** will commence at 2:00pm on 12th Feb, 2011(Saturday) and will be of two (02) hours duration.
- (vi)Candidates must reach their center at least 30 minutes before the commencement of the examination. No candidate will be allowed in the examination center 15 minutes after the commencement of the examination.

7. RESULT AND SELECTION CRITERIA:

- (i) Candidates who secure a minimum of 50% marks in case of General Category and 40% marks in case of Reserved Category in the U.P.G.M.E.E.-2011 shall be eligible for admission to Post Graduate Medical Courses.
- (ii) For MD/MS/Diploma Courses: Inter se Merit of candidates obtaining equal marks shall be determined in order of preference as under:
 - (a) Candidate obtaining higher marks in Paper—II of the U.P.G.M.E.E.-2011. If obtained equal marks then;
 - (b) Candidate scoring less negative marks. If obtained equal marks then;
 - (c) Candidate obtaining higher average aggregate percentage of marks in all professional exams. If obtained equal marks then;
 - (d) According to age i.e. older getting preference over younger (for all courses).
- (iii)Merit list (combined & category wise) of eligible candidates for admission to the Post Graduate Medical courses shall be declared/published by the Registrar (U.P.G.M.E.E.-2011), Uttarakhand Technical University, Dehradun, on website www.uktech.in and in the newspapers (all Uttarakhand & Delhi edition) and shall be displayed at the Office of the Registrar (U.P.G.M.E.E.— 2011), Uttarakhand Technical University, Dehradun and Director General, Health & Family Welfare, Government of Uttarakhand, Dehradun. The copy of result will also be sent to the Principal of Government Medical College, Haldwani and Himalayan Institute of Medical Sciences, Jolly Grant, Dehradun.
- (iv) The allotment of course to the eligible candidates shall be made by the admission committee under chairmanship of an officer appointed by Uttarakhand Government on personal appearance, along with all original documents, of the candidate as per his/her

merit and choice of the course. The date and place of counseling shall be notified through press. No intimation will be sent to the candidate. It will be the responsibility of the candidates to check these dates and appear for counseling and allotment of course. The candidate will have to deposit a fee of Rs. 1000/- at the time of counseling. All available seats in different courses shall be displayed along with it recognization status at the time of counseling. The candidate may choose any one of the available seats according to their merit. A seat once allotted to candidate for any course shall be final.

- (v) In case, a candidate is unable to appear for counseling in person, he/she can send his/her representative with an authority letter on the prescribed Performa as given below for allotment. The allotment made to the authorized representative shall be binding on the candidate. Authority on any other form will not be accepted. It will be necessary for the authorized person to bring original documents of the candidate for obtaining allotment. One person can represent only one candidate.
- (vi) If seats remain vacant after last round of counseling than these vacant seats will filled as follows.
 - (a) OBC category vacant seats will be filled by general category students.
 - (b) If seats of schedule caste/schedule tribal categories remains vacant than these seats will filled by interchanging. If further remains vacant than these seats will be filled by OBC category students and if ample no. of OBC category students is not available than these seats will be filled by general category students.

8. ADMISSION

Admission of the candidates shall be made by the Principal of Government Medical College, Haldwani and Himalayan Institute of Medical Sciences.

- (i) A candidate who had qualified for admission to a postgraduate course shall have to deposit the prescribed fee on the date notified for the purpose in the Medical College. Those who fail to do so will loose their claim for admission in the course and in subsequent counseling if any.
- (ii) Admission in MD/MS/Diploma course shall be given only after the candidate produces the original of the following documents at the office of the Principal of Government Medical College, Haldwani and Himalayan Institute of Medical Sciences, Jolly Grant, Dehradun.
 - (a) High School certificate as proof of date of birth
 - (b) Original Mark sheets of all professional Examination.
 - (c) M.B.B.S. passing out certificate or degree.
 - (d) Compulsory Rotatory internship completion certificate.
 - (e) Permanent Registration Certificate of MCI/State Medical Council.
 - (f) Employer's relieving certificate, if employed.
 - (g) S.C./S.T./O.B.C Certificate, if applicable.
 - (h) Allotment letter, issued by Chairman, Admission Board of U.P.G.M.E.E.-2011.
 - (i) Admit Card of U.P.G.M.E.E.-2011.
 - (j) Domicile certificate on prescribed Performa and Proof of admission through 15% All India quota

- (k) Domicile certificate on prescribed Performa by those candidates who passed M.B.B.S. from Medical College of other state.
- (iii) Candidate shall be required to complete the admission formalities and join the course assigned to them within specified period.
- (iv)At the time of counseling reservation policy will be applicable on whole number of seats as per order of the Govt. of Uttarakhand.
- (v) After allotment of the seats candidates who failed to join the course within the specified period shall forfeit the right of admission and the security.
- (vi)Candidates who are absent or do not wish to opt for a seat in any course amongst the seats available at their merit, shall not be eligible for allotment in subsequent counseling, if any.
- (vii) Candidate willing to opt for a course will have to deposit a bank draft of Rs. 2540/- (two thousand five hundred forty only) in favor of "Director General, Health & Family Welfare, Government of Uttarakhand" (for MD/MS/Diploma courses) payable at SBI Main Branch Dehradun as security money and the same will be returned to the candidate after he/she takes admission. Those who do not join or leave the course after allotment / admission will forfeit their claim of refund of security deposit.

9. APPLICATION FORM SHALL ACCOMPANY THE FOLLOWING DOCUMENTS:

Completed Application forms must be accompanied with the checklist provided below.

- (a) Attested photocopy of High School pass certificate as proof of date of birth.
- (b) Attested photocopy of the mark sheets of all the three professional examinations of M.B.B.S.
- (c) Attested photocopy of the compulsory rotatory internship certificate.
- (d) Attested photocopy of provisional / permanent medical registration of the MCI/State Medical Council.
- (e) Eligible candidates belonging to reserve category, must submit a certificate on the attached Performa certified by any competent authority. In case the certificate is not as per prescribed Performa the benefit of reservation shall not be allowed.
- (f) Attested photocopy of M.B.B.S. passing out certificate.
- (g) Any other certificate.
- (h) A demand draft of Rs. 5000/ or Rs. 2500/- payable to Finance Controller, UTU, Dehradun, only by those, who are submitting downloaded application forms.
- (i) Proof of admission in Government Medical College, Haldwani **or** Himalayan institute of Medical Sciences through competitive examination **or** Not under NRI/Management quota (for MD/MS/Diploma courses only).
- (j) **Domicile certificate:** Candidate shall submit their domicile certificate of Uttarakhand and or proof of admission in Medical Colleges of other states through 15% All India Quota. If studied their MBBS from other states.
- (k) For PMHS (Provincial Medical and Health Services) doctors No Objection Certificate from Director General, Medical, Health and Family Welfare, Uttarakhand is required.
