32. Regarding recognition of degrees/diplomas of CMJ University, Shilong

Considered the action taken by the Vice-Chancellor, in anticipation of the approval of the Academic Council, in approving that the name of CMJ University, Shilong (under Private Universities) appearing at Sr. No. 30 on page 36 of Recognition/Equivalence List-2011 be kept in suspended animation and that the degrees/diplomas of the said University be not considered for admission w.e.f. the session 2013-14 till the matter is finally sorted out by the University, University Grants Commission and the State Government, in view of the advice of the Hon'ble Governor of Meghalaya received through the State Government (Annexure A/42 pages 225-230, already circulated).

NOTE:

As per Note 2 at page 1 of the Recognition/Equivalence List-2011, all the examinations of Statutory Universities including Open/Private Universities established by an Act of the State/Central Government which are approved by the University Grants Commission are recognized by this University for admission to various courses. The name of CMJ University, Shilong is in the list of Private Universities approved by the University Grants Commission appearing at Sr. No. 30 on page 36 of the Recognition/ Equivalence List 2011 of this University.

News are floating in the newspapers about the CMJ University, Meghalaya. The Hon'ble Governor, Meghalaya being Visitor of the University has written a letter to the Hon'ble Governor of Haryana inviting attention to a letter addressed to Shri Chander Mohan Jha, Chairman, CMJ University, Shilong (Sponsoring Body of that University) vide which directions have been given that the University shall recall/withdraw all the degrees awarded so far and publish this fact in national and local newspapers at their own cost. The CMJ University challenged the above directions in the Meghalaya High Court vide a writ appeal No. 16 of 2013, which has been dismissed by the Hon'ble High Court.

A copy of the directions of the Hon'ble Governor of Meghalaya have been received in the University through the Director General, Higher Education, Panchkula vide memo No. 20/11-2013 UNP(5) dated 01.07.2013 (Annexure A/42 pages 225-230, already circulated). As the admission process in the University Teaching Departments and the affiliated Colleges was going on and queries were being raised by the Departments/affiliated Colleges regarding admission of students, who have passed various examinations from that University, the Vice-Chancellor after considering the above facts has taken the above action. This decision taken by the Vice-Chancellor has been conveyed to all the
