Other provisions and instructions required for filling of Online Applications are given as under:

- Applicant should apply for one post only. Candidates availing the facility of reservation under any category should clearly mention the category applicable. Under any circumstances, change of data will not be allowed after successful submission of Application form. However submitted application form can be viewed and downloaded/printed. On detection of incorrect information or submission of false/fake documents will lead to cancellation of candidature/appointment at any stage.
- **Pay Scale :** as per rules of UPPCL. Pay Band-3; Rs. 15600-39100 + Grade Pay Rs. 5400/- Dearness and other allowances admissible

4. Essential Qualification:

(A) Candidates should have thorough knowledge of Hindi (Devnagri script). If the candidate has not passed High school or equivalent examination in Hindi, he/she has to to clear an exam conducted by the Registrar, Department Examination Govt. Of U.P. within 3 years of joining. (B) A bachelor's degree in Electrical Engineering / Civil Engineering from a University OR Institution established by law in Uttar Pradesh or from any other Institution recognized by State Government or a degree recognized as equivalent thereto by the State Government OR Part-A & B examinations conducted by the Institution of Engineers (India).

Clarification Note:- Candidates having degree through Distance Education Programme are $\underline{not\ eligible}$ to apply for the above posts.

- 5. (A).Age: Minimum 21 years and maximum 40 years as on 01-01-2015.
 - (B) Relaxation in upper age limit: (I) Apprenticeship training under Apprenticeship Act 1961 –Actual period ,subject to maximum Twelve months . (II) SC, ST & OBC (non-creamy layer) of Uttar Pradesh domicile -5 years(III)Dependents of freedom fighters-5 years (IV) Physically handicapped (OA/OL) candidates (40% and above disability) -15 years. However maximum age of a candidate availing all relaxations shall not exceed 50 years.
- Reservation: (I) Reservation will be provided as per Reservation rules of UP Govt. to SC, ST and OBC (non creamy layer) candidates who are original inhabitants of Uttar Pradesh (Domicile of Uttar Pradesh only). (II) SC, ST and OBC (of other states) & OBC (coming under 'creamy layer' of U.P.) may apply as General Category candidate.(III) Horizontal reservation will be provided as per existing orders of UPPCL.
- No Objection Certificate: Candidate who are working with any State Govt./Central Govt./Semi-Govt./ Govt. Undertaking organization ,shall have to submit 'NOC' from their present Employer at the time of Joining.
- Examination center & Selection Process: Selection Process will be based on Computer Based Test and 8. interview. Computer Based Test(CBT) will be held at Allahabad, Varanasi, Gorakhpur, Agra, Kanpur, Bareilly, Lucknow, Ghaziabad, and Meerut cities .(Eletricity Service Commision, however have the right to cancel any of the Examination City/ Center and/or add some other cities/centres depending upon the response, administrative feasibility, or any force-majeure conditions etc.) The test shall comprise of total 200 questions, out of which 150 questions shall be from the Bachlor level Engg. Branch syllabus for the Post applied, 20 questions of General Knowledge/Awareness, 20 questions of Reasoning and 10 questions of General Hindi. Each correct answer shall carry one mark each and each wrong answer shall carry negative mark of 0.25. Interview will be conducted at Lucknow only. Candidates who obtain less than 33 % marks will be rejected for further process of selection. On merit maximum numbers of candidates to be shortlisted for interview will be equal 2 to 3 times the number of vacancies. Candidates with same marks as that of last shortlisted Candidate will also be called for interview. If a candidate is shortlisted for interview, then appearing in interview is compulsory, failing which candidature will be treated as cancelled. Finally, the merit list shall be prepared on the basis of the combined marks obtained in the CBT and interview, branch wise category wise. सेवा आयोग

- *Candidates having undergone apprenticeship training under Apprenticeship Act 1961, will be given age relaxation and preference as per order of Hon'ble Supreme Court, in case, all other requisite parameters being the same.
- 9. <u>Training:</u> The selected candidate has to undergo a training programme, for a period as decided by UPPCL. On successful completion of the training, the candidate shall be considered for absorption as per existing rules of UPPCL.
- **Transparency:** For the complete transparency of the held CBT, the Electricity Service Commission shall arrange to display the answer–key for 3 days on the official website of UPPCL, after two days of the examination. The candidate can lodge their protest online, if any, along with proper proof within 3 days from the last date of display of answer–key. Electricity Service Commission will refer the cases to a panel of experts, whose decision shall be final and therafter result will be processed accordingly. After the expiry of this period, any objections shall not be entertained.
