Under any circumstances, change of data will not be allowed after successful submission of Application form. However submitted application form can be viewed and downloaded/printed. On detection of incorrect information or submission of false/fake documents will lead to cancellation of candidature/appointment at any stage.
- 3. Pay Scale: as per rules of UPPCL. Pay Band-3; Rs. 15600-39100 + Grade Pay Rs. 5400/Dearness and other allowances admissible.
- 4. Essential Eligibility Qualifications:
  - (A) Candidates should have sufficient knowledge of Hindi in Devnagri Lipi.
  - (B) A degree in Electronics Engineering or Communication Engineering or Telecommunication Engineering a mixed discipline (युग्म) degree combined with either Electronics Engineering or Communication Engineering or Telecommunication Engineering.

### Note:-

- (i) The above degree must be obtained from a University incorporated by an Act of the Central or State Legislature in India or other Educational Institutions established by an Act of Parliament or declared to be deemed as Universities under Section 3 of the University Grants Commission Act 1956, as a full time regular degree course (OR) passed Section A and B of the Institution Examinations of the Institution of Engineers (India) in relevant discipline as mentioned above.
- (ii)Degree/Diploma received through Distance Learning Education will not be eligible in direct recruitment as well as in promotion.
- 5. (A) Age: Minimum 21 years and maximum 40 years as on 01-01-2016.
  - (B) Relaxation in upper age limit: (I) Apprenticeship training under Apprenticeship Act 1961–Actual period , subject to maximum Twelve months .(II) SC/ ST/ OBC (non-creamy layer) of Uttar Pradesh domicile -5 years.
- Reservation: (I) Reservation will be provided as per Reservation rules of UP Govt. to SC, ST and OBC (non creamy layer) candidates who are original inhabitants of Uttar Pradesh (Domicile of Uttar Pradesh only). (II) Candidates of SC, ST & OBC (Creamy Layer) category of States/Union Territories other than Uttar Pradesh should apply as General Category candidate. (III) Horizontal reservation will be provided as per existing orders of UPPCL, if applicable.
- No Objection Certificate: Candidate who are working with any State Govt./Central Govt./Semi-Govt./ Govt. Undertaking organization ,shall have to submit 'NOC' from their present Employer at the time of Joining.
- 8. Examination center & Selection Process: Selection Process will comprise of Computer Based Test and interview. Computer Based Test(CBT) will be held at Allahabad, Varanasi, Gorakhpur, Agra, Kanpur, Bareilly, Lucknow, Ghaziabad, and Meerut cities. Eletricity Service Commission, however will have the right to cancel any of the Examination City/ Center and/or add some other cities/centres depending upon the response, administrative feasibility, or any force-majeure conditions etc.) The test shall comprise of total 200 questions, out of which 150 questions shall be from the Bachelor level Engg. Branch syllabus, 20 questions of General Knowledge/Awareness, 20 questions of Logical/Verbal Reasoning and 10 questions of General

Hindi. Each correct answer shall carry one mark each and each wrong answer shall carry aditional negative mark of 0.25 marks. Question not attempted shall carry no marks. Interview will be conducted at Lucknow only. Candidates who obtain less than 33 % marks will be rejected for further process of selection. Depending on the number of candidates, maximum numbers of candidates to be shortlisted for interview will be equal 2 to 3 times the number of vacancies. Candidates with same marks as that of last shortlisted Candidate will also be called for interview. If a candidate is shortlisted for interview, then appearing in interview is compulsory, failing which his/her candidature will be treated as cancelled. Finally, the merit list shall be prepared on the basis of the combined marks obtained in the CBT and interview.

- **Training:** The selected candidate has to undergo a training programme, for a period as decided by UPPCL. On successful completion of the training, the candidate shall be considered for absorption as per existing rules of UPPCL.
- Transparency: For the complete transparency of the held CBT, the Electricity Service Commission shall arrange to display the answer-key or provide a link to download the question paper alongwith answer -key, for 3 days on the official website www.uppcl.org within 48 hours of the examination. The candidate can lodge their protest online, if any, along with proper reference and proof within 3 days from the last date of display of answer-key. Electricity Service Commission will refer the cases to a panel of experts, whose decision shall be final and thereafter result will be processed accordingly. After the expiry of this period, any objections shall not be entertained.
