ELIGIBILITY CONDITIONS:

85% of the total 50 seats for BAMS Course will be filled up from amongst the Bonafide residents of Himachal Pradesh. Two seats are reserved for Govt. of India Nominees (i.e. for J&K State) and rests of the seats are open seats to be filled in All India basis.

<u>Age for BAMS Course:</u> The candidate should have attained the age of 17 years and must not have completed 25 years of age as on **Ist of October, 2009**.

<u>Educational Qualification for BAMS Course:</u> The candidates should have passed/ appeared in 10+2 or equivalent examination with 50% aggregate marks in Physics, Chemistry and Biology (40% marks in case of SC/ST/OBC) and must have passed English as an elective subject.

The Govt. of India nominees shall have to fulfill the eligibility conditions i.e. minimum educational qualification i.e. should have passed 10+2 (Physics, Chemistry, Biology) having at least 55% marks and age condition as mentioned above for BAMS but they will not be required to compete in the entrance test.
