In exercise of the powers conferred by sub-section (1) of Section 14 of the Karnataka Educational Institutions (Prohibition of Capitation Fee) Act, 1984 (Karnataka Act 37 of 1984), the Government of Karnataka hereby makes the following rules further to amend the Karnataka Selection of Candidates for Admission to Master of Engineering (M.E) and Master of Technology (M.Tech.,). Courses Rules, 2005, namely:-

- 1. Title and Commencement. These rules may be called the Karnataka Selection of Candidates for Admission to Master of Engineering (M.E.,) and Master of Technology (M.Tech.,) courses (Amendment) Rules, 2011
- (2) They shall come into force from the date of their publication in the official Gazette.
- 2. Amendment of rule 2.- In the Karnataka Selection of Candidates for Admission to Master of Engineering (M.E.,) and Master of Technology (M.Tech.,) Courses Rules, 2005, (hereinafter referred to as the said rules) in rule 2,-
 - (i) for clause (c), the following shall be substituted, namely:-
- "(c) "Committee" means Executive Committee of the Karnataka Examinations Authority".
 - (ii) after clause(d), the following shall be inserted, namely:-
- "(dd) "Executive Director" means an officer appointed by the Government who is holding the Commissioner's post in Pre-University Education, Banglore for conduct of Common Entrance Test and Regulating of all matters pertaining to seat selection and admission to the courses notified by the Government"
 - (iii) after clause (e), the following shall be inserted, namely;-

- "(ee) "KEA" means Karnataka Examinations Authority registered under the Karnataka Societies Registration Act, 1960 (Karnataka Act 17 of 1960)"
- 3. Amendment of rule 4.- For rule 4 of the said rules the following shall be substituted, namely:-
- "4. State Level Common Entrance Test.- The Karnataka Examinations Authority (KEA) shall conduct State Level Common Entrance Test for selection of candidates for Admission to Master of Engineering (M.E.,) and Master of Technology (M.Tech.,) Courses (both full time and part time) for all the seats in University Department, constituent Colleges and all affiliated Colleges in the State of Karnataka".
- 5. Amendment of rule 11.- In rule 11 of the said rules in sub-rule (3) for the words "Member Secretary, CPAC, payable at Belgaum" the words "The Executive Director, Karnataka Examinations Authority, payable at Bangalore" shall be substituted.
- 6. Amendment of rule 18: In rule 18 of the said rules in subrule (1) for the word 'CPAC' the words "Karnataka Examinations Authority" shall be substituted.

NOTIFICATION-I

In exercise of the powers conferred by sub-section (1) of Section 14 of the Karnataka Educational Institutions (Prohibition of Capitation Fee) Act, 1984 (Karnataka Act 37 of 1984), the Government of Karnataka hereby makes the following rules further to amend the Karnataka Selection of Candidates for Admission to Master of Business Administration and Master of Computer Application Courses Rules, 2005, namely:-

- 1. Title and Commencement. These rules may be called the Karnataka Selection of Candidates for Admission to Master of Business Administration and Master of Computer Application Courses (Amendment) Rules, 2011
- (2) They shall come into force from the date of their publication of the official Gazette.
- 2. Amendment of rule 2.- In the Karnataka Selection of Candidates for Admission to Master of Business Administration and Master of Computer Application Courses Rules, 2005(hereinafter referred to as the said rules) in rule 2,-
 - (1) for clause (b), the following shall be substituted, namely:-
- "(b) "Committee" means Executive Committee of the Karnataka Examinations Authority."
 - (2) after clause(c), the following shall be inserted, namely:-
- "(cc) "Executive Director" means an officer appointed by the Government who is holding the Commissioner's post in Pre-University Education, Bangalore for conduct of Common Entrance Test and regulating of all matters pertaining to seat selection and admission to the courses notified by the Government".
- (3) after clause (g) and entries relating thereto the following shallbe inserted, namely:-
 - "(gg) "KEA" means Karnataka Examinations Authority registered under the Karnataka Societies Registration Act, 1960 (Karnataka Act 17 of 1960)"

- (4) for clause (p), the following shall be substituted, namely:-
- "(p) "State Level Common Entrance Test" means "the Post Graduate Entrance Test" conducted by the Executive Director, for Government seats and for management seats in case of institutions which have requested the Kamataka Examinations Authority (KEA) to conduct the Common Entrance Test".
- 3. Amendment of rule 4.- For rule 4 of the said rules, the following shall be substituted, namely:-
- "4. Conduct of state level Common Entrance Test. The Karnataka Examinations Authority (KEA) shall conduct State Level Common Entrance Test i.e., Karnataka Post Graduate Common Entrance Test (PGCET) for selection of candidates for Government Seats and also for the management seats, if the management requested the Karnataka Examinations Authority (KEA) to fill their Management quota seats through State Level Common Entrance Test i.e., Karnataka Post Graduate Common Entrance Test (PGCET) conducted by Karnataka Examinations Authority (KEA) at Government, the tuition fee payable shall be as notified by the State Government".
- 6. Amendment of rule 11.- In rule 11 of the said sub rules in sub-rule (2) for the words "Member Secretary, CPAC, payable at Belgaum" the words "The Executive Director, Karnataka Examinations Authority, payable at Bangalore" shall be substituted.
- 7. Amendment of rule 15. In rule 15 of the said rules, in subrule (1) for the word "CPAC" the words "Karnataka Examinations Authority" shall be substituted.
