

III. ELIGIBILITY FOR ADMISSION

(a) M. Sc. in Bio-Technology:

Any person who has passed the qualifying degree examination specified in the Table given below with a minimum of 45% of marks in the aggregate or in the honours subject for the candidates belonging to the general category (a minimum of 40% of marks in the aggregate or a minimum of 45% in the honours subjects for the candidates belonging to the Scheduled Castes and the Scheduled Tribes).

(b) M.Sc. in Geophysics/M. Sc. in Marine Microbiology:

Any person who has passed the qualifying degree examination as specified in Table given below with a minimum of 45 % of marks in aggregate or in honours (a minimum of 40% of marks in the aggregate or a minimum of 45% of marks in the honours subject for candidates belonging to the Scheduled Castes and the Scheduled Tribes) is eligible for consideration of admission.

(c) M. Tech in Computer Science/M. Tech. in Electronic Information Systems:

Any person with a Master's Degree or B.E/B.Tech. Degree with the subjects mentioned in the Table given below with at least 50 % of marks in the aggregate or equivalent grade point.

(d) M. Pharm.

Any person with a B. Pharm. Degree with at least 50% of marks in the aggregate or equivalent grade point

(e) **M.F.C.**

Any person who has passed the qualifying degree examination as specified in Table given below with a minimum of 50 % of marks in aggregate or in honours (a minimum of 45% of marks in the aggregate or in the honours subject for candidates belonging to the Scheduled Castes and the Scheduled Tribes) is eligible for consideration of admission.

IV. PROCEDURE FOR ADMISSION AND DETERMINATION OF MERIT

- (a) Candidates seeking admission to M.Tech in Computer Science, M.Tech. in Electronic Information Systems, M.F.C. and M.Pharm. shall have to appear at and qualify in the **Admission Test** conducted for the purpose by the concerned Course Coordinator on the dates and time specified in the Prospectus and merit shall be determined on the basis of the marks secured in the Admission Test along with their career points as per the procedure prescribed for the courses.
- (b) For admission into M.Sc. in Biotechnology/M.Sc. in Geophysics/M.Sc. in Marine Microbiology merit shall be determined on the basis of career points prescribed for the courses.

Admission to all the above courses shall be governed by the Regulations of the University and Rules for Admission framed by the P.G. Council and duly approved by the Syndicate.

A candidate whose conduct is not satisfactory shall NOT be considered for admission.

V. RESERVATIONS

Reservations for the Scheduled Castes & Scheduled Tribes: 22.5 % of the seats in different courses are reserved i.e. for candidates belonging to the Scheduled Tribes (13%) and the Scheduled Castes (9.5%).

For consideration under the Reserved Categories necessary certificate to this effect issued only by a **Revenue Officer of the locality not below the rank of a Tahasildar must be submitted**.

- 2. I do hereby declare that I have not been admitted to any other course(s) nor shall I appear at any other examination as long as I continue my studies in the course, if admitted.

If at any time it is found that I have violated the above conditions, I shall be liable to forfeit my seat, cancellation of my admission and such other penal action as may be considered appropriate by the University. I shall not claim the refund of the course fee and other fee deposited at the time of admission.

VI. ADMISSION FOR FOREIGN STUDENTS

Fifteen percent supernumerary seats may be created in all the above courses for admission of foreign students. These seats shall be exclusively meant for foreign students. No candidate from a foreign country will be considered for admission unless his/her case has been sponsored by the relevant Department/Ministry, Government of India. The sponsored candidates will be required to submit in the prescribed proforma a Medical Fitness Certificate from a Registered Medical Practitioner not below the rank of CDMO within a month of their provisional admission, besides such other documents as are required under the rules/instructions of the Government of India/Orissa.

Foreign students who have passed the qualifying examination from a foreign country taking admission in the courses have to pay Rs. 10,000/- more along with other fees for the entire course.

VII. ADMISSION TEST

- (A) The Admission Test for M. Tech. courses shall be conducted through a written examination of 2 hours duration with a maximum of 100 marks. The questions in the admission test shall be objective (multiple choice type) and will be set and answered in English language only.
- i) Syllabus for Admission Test for M. Tech. in Computer Science: Algorithms, Programming in C and C++, Data and file structures, logical organization of computers, Computer Architecture, Data Base, Operating systems, Data Communications, Computer Networks, Software Engineering, System Software, Artificial Intelligence, Computer Graphics, Network Security and Mathematical Foundations of Computer Science.
- ii) Syllabus for Admission Test for M. Tech. in Electronic Information Systems: Electronic Material, Solid State Devices, Numerical Methods, Network Analysis, Control, Microwave, Digital & Analogue Electronics, Instrumentation, Microprocessor (8085 & 8086), Signals & Systems, Communication, Optoelectronics, DSP, VLSI, Optical Communication, Telematics.
- (B) **Admission Test for M.F.C. Course:** Questions of general nature relevant to the subject shall cover 100 marks and questions on general awareness, comprehension, aptitude and reasoning shall be for 40 marks as per the requirement of the course. The test shall be of 2 hours duration for 140 marks and the questions shall be objective (multiple choice type) and will be set and answered in English language only.
- (C) Admission Test for M. Pharm. course: The Admission Test for admission into M. Pharm. course shall be through a written examination of 2 hours duration with a maximum of 140 marks. The questions shall be objective (multiple choice type) and will be set and answered in English language only. The questions for the admission test shall be set broadly from the B. Pharm. syllabus covering the areas like Pharmaceutics, Pharmaceutical Jurisprudence, Pharmaceutical Analysis, Biochemistry, Microbiology, Pharmacognosy and Phyto-chemistry, Pharmacology and Medicinal Chemistry.

(D) Other Criteria:

- (a) Candidates having Bachelor degree in Biotechnology will be given 10 additional career points for admission into M.Sc. Biotechnology.
- (b) Candidates who have submitted Mark Sheet in grade scale are required to produce the equivalent marks from the institution, which has issued that mark sheet along with the application.
- (c) For admission to M.Tech. Computer Science, candidates having Masters Degree in Computer Science/Computer Application/Information Technology or B.E./B.Tech. in Computer Science/Computer Application/Information Technology shall be given an additional 10 Career Points.
- (d) For admission into M.F.C. Course, candidates having Commerce as a subject at the graduation level shall be given additional career points as per the following:

i. Ist Class Honours: 10 marks
 ii. 2nd Class Honours: 07 marks
 iii. Pass/General: 05 marks

(e) Students with valid GATE/GPATE ranking/Score will be given additional 10 career points for admission into M.Tech. in Computer Science, M.Tech. in E.I.S and M.Pharm. courses.

IX. FEE TO BE PAID ALONG WITH THE APPLICATION FORM DULY AUTHENTICATED

(a) For M.Tech. in Computer Science/M.Tech. in Electronic Information Systems/MFC/M. Pharm. for which Admission Test will be conducted

Along with the printout of on-line/PDF downloaded/printed application form, a candidate shall have to pay an examination fee of Rs.600/- (Rupees six hundred) only for the Admission Test in the form of Account Payee Bank Draft drawn in favour of the "Coordinator" of the course to which admission is sought and payable at the State Bank of India, Bhanja Bihar (Code 2107), Berhampur – 760 007.

Candidates who are applying in the printed form purchased from the P.G. Central Office, Berhampur University shall have to pay an amount of Rs. 400/- Rupees four hundred) only drawn in favour of the Coordinator of the course to which admission is sought and payable at the State Bank of India, Bhanja Bihar (Code 2107), Berhampur – 760 007.

(b) For M.Sc. in Biotechnology/M.Sc. in Geophysics/M.Sc. in Marine Microbiology courses:

Candidates seeking admission into the above courses should enclose with the application form an Account Payee Bank Draft of Rs. 400/- (Rupees two hundred only) towards processing fees, drawn in favour of the Coordinator of the course to which admission is sought and payable at the State Bank of India, Bhanja Bihar (Code 2107), Berhampur – 760 007.

Candidates who are applying in the printed form purchased from the P.G. Central Office, Berhampur University shall have to pay an amount of Rs. 200/- Rupees two hundred) only towards processing fees, drawn in favour of the Coordinator of the course to which admission is sought and payable at the State Bank of India, Bhanja Bihar (Code 2107), Berhampur – 760 007.

Note: Fee once paid shall not be refunded.

<u>Note:</u> Unless the signed hardcopy along with all enclosures and application fee is received on or before the last date by the Coordinator of the concerned course of the Department, the online application will not be considered for admission.

PDF: Please download PDF Form from website: www.bamu.nic.in

Printed: Applicants are advised to apply on-line or apply in downloaded PDF form by visiting the website www.bamu.nic.in. However, printed applications are also available in the P.G. Central Office, Berhampur University on payment.

Application forms for admission can be obtained in person from the P.G. Central Office Counter on working days from 11.00 a.m. to 3.00 p.m. on payment of Rs.200/- (Rupees two hundred) only through Bank Challan available at *SBI Bhanja Bihar*. Application forms can also be obtained by post on payment of Rs. 200 (Rupees two hundred) only in the form of Account Payee Demand Draft drawn in favour of the **COMPTROLLER OF FINANCE**, **BERHAMPUR UNIVERSITY** and payable at the **STATE BANK OF INDIA**, **BHANJA BIHAR (BRANCH CODE: 2107)** along with a self-addressed envelope (size 30 x 12 cm) affixed with postal stamps worth Rs. 40/- (Rupees forty only) for each application form. The applicant should write his/her name and address on the back side of the Bank Draft.

MONEY ORDERS AND POSTAL ORDERS SHALL NOT BE ACCEPTED UNDER ANY CIRCUMSTANCES.

XI. SUBMISSION OF APPLICATIONS FOR ADMISSION

Candidates seeking admission into the different courses shall have to send their applications in the prescribed form duly filled in by them in their handwriting along with the required documents and fee (complete in all respects) to the **Course Coordinator to which admission is sought** by **Registered/ Speed Post**. The application forms will not be accepted in person, either in the P.G. Central Office or by the Course coordinator. **The application along with the required documents and fee must reach the Course Coordinator on or before the prescribed date, i.e., 7th July 2010, failing which it will be summarily rejected.**

Online applicants are advised to apply much in advance of the scheduled last date and not to keep it for last hour rush. The university will not be held responsible for any network failure.

University Authorities shall not be responsible for postal delay.

XII. POSTAL ADMISSION PROCEDURE

For admission to all courses, the University has adopted Postal Admission System. The procedure of postal admission is as follows:

Merit List Candidates: After receiving the intimation for admission from the respective Course Coordinator, the candidate should send by **Registered/ Speed Post** all the required documents in original including a self addressed envelope and the prescribed fee in the form of Bank Draft (s).

Waiting List Candidates: After receiving intimations, such candidates shall follow the same procedure for admission as laid down above for merit list candidates. Submission of documents by the Waiting List candidates is voluntary and at their own risk. The University does not guarantee admission to candidates kept in the Waiting List. Only after finalisation of admission of Merit List candidates, if seats remain vacant, the candidates in the Waiting List shall be considered for admission in order of their merit position in the Waiting List. As the admission of Merit List and Waiting List candidates is to be finalised simultaneously, the merit list and waiting list candidates are to send by **Registered Post/Speed Post** the required documents along with the prescribed fee within the date mentioned in the Intimation Letter.

NOTE:

- (a) Candidates who have either been selected or waitlisted for admission into more than one course should send the Bank Draft (s) to each Course Coordinator separately, failing which they will not be considered for admission. However, they are required to send their original documents to the Coordinator of the course of their first preference indicating the names of other courses for which they have been selected / waitlisted.
- (b) Submission of Transfer Certificate/College Leaving Certificate in **original** is compulsory for both Merit List and Waiting List candidates.
- (c) Applications incomplete in any respect are liable to be summarily rejected. No correspondence in the matter shall be entertained.
- (d) Failure to send the original documents and the required Bank Drafts as per Intimation Letter by the date and time specified therein shall result in forfeiture of the claim for a seat. **University Authorities shall not be responsible for postal delay.**
- (e) The original documents and the Bank Draft (s) of candidates who are not admitted will be returned to them by **Registered Post/Speed Post** after the admissions are over. However, the concerned candidates can take back the original documents by submitting an application to the Course Coordinator before the completion of the admission procedure. For candidates who have been admitted, the original documents not required by the University, may be collected from the concerned Course Coordinator/ Head of the Department after the admission is finalised.
- (f) The decision of the Course Coordinator/ Head of the Department in all matters relating to admission shall be final and binding.

XIII. FIELD STUDY, OBSERVATION, INTERNSHIP, etc.

Students admitted to such subjects where the curriculum includes Project Work, field study, observation, internship, industrial visits shall have to undergo all such field study, observation, internship, industrial visits at their own cost and risk as per rules.

Fee once collected at the time of admission shall not be refunded under any circumstance.

(C) Department Seminar Fee: The students shall have to pay seminar fee and any other fee to the course Coordinator as decided by the concerned Department/ Course Coordinator.

NB: The University shall not provide any transport facilities and the students are to make their own arrangements for their conveyance.

XV. HOSTEL FACILITIES:

Hostel facilities will be provided to the students of self-financing courses subject to availability of seats in the P.G. Hostels for Boys and Girls.. In the event of allotment of hostel seats the students shall have to abide by the Rules and Regulations of the Hostel and pay the requisite fees at par with the regular students.

XVI. COMMENCEMENT OF CLASSES

Classes of the different courses will commence on the date and time to be notified by the respective Course Coordinators. Normally the classes will be held during morning and evening hours as decided by the Course Coordinators of the respective courses.

XVII. The University reserves the right to conduct or cancel any course, if adequate number of students do not register due to some reason or other.

XVIII. Steps will be taken to assist the students for placement.

XIX.DISPUTES

All disputes concerning admission and studentship are subject to the exclusive jurisdiction of the Civil Courts and legal fora at Berhampur (Ganjam). All admissions are provisional and can be cancelled at any time for any valid reason such as misconduct, forgery, etc.

XX. RAGGING

Ragging in any form is strictly prohibited. Severe action shall be taken as per rules against those involved in ragging. As per the U.G.C guide line 6.1 (d & e) of the regulation (F-1-16/2007 (CPP – II/dated 17June 2009), it is mandatory for all the applicants to submit an affidavit in a non-judicial stamp paper as per the prescribed proforma enclosed in the prospectus, if admitted.
