- You may kindly recall that while giving approval to Govt. of UP for conduct of Special BTC we have allowed all B.Eds to be eligible for the above course as requested by Govt. of UP. As such, the degree awarded by IGNOU, a Central University and institution/university recognized by the NCTE cannot be treated as inferior to other B.Eds.
